It wasn't until I actually got sober that I understood powerlessness. That once I took that first drink, I had no defense against taking the next one. I tried to stop several times during that last year of daily drinking but, once I decided to stop, drinking was all I could think about. Then when I finally got sober and heard what was being said at meetings I kept hearing the same thing. No matter how long we hadn't drank, once we took a drink we had to have another then another. I could finally admit that I was an alcoholic and the only way I could never drink again was to NOT take that first drink.

But, the unmanageable part was a bit harder to admit. I had a home and family (kind of). But why then was I heating water over a fire outside so I could bathe and do dishes. I was living by lantern light because the electricity was off too. This I called manageable? Oh so maybe this is what the steps are for. So I can find out why I do the things I do. So, I started on the journey through the steps of Alcoholics Anonymous and my life began to change. Today I live a life that I could never have imagined possible because I finally did a thorough and honest Step One.

Our common welfare comes first; personal recovery depends upon A.A. unity.

The fellowship of Alcoholics Anonymous is represented by our circle and triangle symbol. The three sides of the triangle are said to be recovery, service, and unity. If any of the three are missing, the triangle falls. They are all equally essential for A.A. survival. Unity goes to the very heart of why we exist at all. Our belief is that it is very rare indeed that an individual alcoholic can recover on his or her own. We need help, from God foremost, but other alcoholics as well. From its inception, A.A. has been a group effort. It started as an offshoot of the Oxford Groups, some of whose alcoholic members became the first A.A. groups. The co-founders needed each other to stay sober. I tried to quit drinking on my own and failed many times. I stopped drinking only with the help of sober members of Alcoholics Anonymous. It says in the long form of Tradition One, "A.A. must continue to live or most of us will surely die." It is clear, that recovering alcoholics need each other and so must stay together. The challenge is how to achieve this without violence or related crimes. The need for unity is why Bill W. wrote the Traditions. They represent spiritual principles that have allowed A.A. to survive. Tradition One is the over-riding principle that the group come first, and the individual alcoholic follows closely afterward. The eleven Traditions which follow offer specific protections for group unity. They can be applied to help solve common problems that A.A. groups can encounter. The Traditions are not philosophy; they are practical safeguards developed through actual experience. If rigorously adhered to, the Traditions help suppress egos and develop genuine humility in our groups. The Twelve Steps and Twelve Traditions says that Step One is the only step that "can be practiced with absolute perfection". I believe the same is true of Tradition One. It must be perfectly clear to every A.A. member that the group comes first in all matters. All of our individual ambitions, needs, fears and desires must follow.

Each member of Alcoholics Anonymous is but a small part of a great whole. Tradition One ensures that we will remain whole. Mark G.

**Doug H.-Acceptance Group-**This is an open, Gay AA meeting in Porterville but everyone is welcome. We meet at the First Congregational Church on Fourth & Mill. This is a 1 hr meeting from 6-7 pm every Wednesday. The meeting has been growing; there have 20 - 25 people in attendance recently. We discuss what is going

on in your sobriety today. Birthdays are celebrated on the last Wednesday of the month. Our group has been able to contribute to Central Office.

Reyes.-The Rainbow Group-This is an open gay AA meeting but everyone is welcome. It is held at the Kaweah Delta Rehab Facility in Visalia, in the Polar Bear room, every Saturday from 5:30 – 7:00 pm. We have a very good mix of newcomers and long timers coming from Fresno, Kings and Tulare counties. We hand out newcomer packets and AA Big Books free to newcomers. Court/Program cards are signed. Each meeting is a chip meeting and birthdays/anniversaries are celebrated on the last Saturday of each month with a delicious cake. We close the meeting with the "Responsibility Declaration. Rotation of service positions starts January 2017.

Reyes-Friday Foundation Group-Come and join us every Friday from 7 pm to 8 pm for a Closed Big Book Study meeting. It is held at the Center for Spiritual Living in Visalia. Court/Program cards are signed. Learn how members recover and how the AA society functions. We open our meeting with the "Set Aside Prayer" and close with the "Responsibility Declaration".

Mark G.-Valley Group-The Valley Group presents a speaker meeting each Wednesday night at the Creative Center in Visalia. This is located at Race & Santa Fe in Visalia, next to the Ice House Theater. Carolyn W.-Springville Speaker Breakfast-We meet on the 2<sup>nd</sup> Sunday of each month at the Veteran's Memorial Building in Springville. Breakfast is served between 8 and 10 am. and costs \$5.00. We usually serve around 65-80 breakfasts. The meeting starts at 10:15 with a 10 minute speaker. The main speaker starts around 11 am. Our Speaker for January is Anita B from Lemoore. Good food and great fellowship. Come and join us! We need a new treasurer.

**Julie M - Springville Gut Level Group-**We meet from 7 – 8:30 at the Lighthouse Chapel every Thursday night. This is an open meeting and all are welcome. We just ask if you are not an alcoholic that you please do not share-you are more than welcome to stay and listen. Attendance is usually 20–25 each week with various

lengths of sobriety. Birthdays are celebrated the last Thursday of the month.

Sheri T-Tues Women's Amity Group— This is a closed women's meeting on Tuesdays at 6:30 – 8 pm. We meet at Trinity Christian Church, 6400 W Walnut Rd, Rm 10. We discuss a topic related to alcoholism every week and the last week is a birthday meeting where we end with a delicious treat. The 3<sup>rd</sup> Tuesday is our business meeting and meet after the meeting. We have 15-30 women from newcomers to long timers sharing their experience, strength & hope.

**Stella T - Women's Changes-** This is an open women's meeting each Tuesday evening at 7 pm at the Church of the Nazarene, 2005 W Olive St. in the Hope Room. This is a 1 hour meeting. A chairperson reads from AA approved materials and shares from their personal experience as it relates to the reading. The meeting is then open for discussion. Our business meeting is held the 3<sup>rd</sup> Tuesday of the month during the final 15 min of the regular meeting. We celebrate AA birthdays on the last Tuesday of the month with either a potluck or a restaurant gathering before the meeting. Cake is served following the birthday mtg.

**Blake-Serenity Seekers** – **Sun P-** We meet at the Serenity Center on Locust Ave & Acequia from 7:30-9 pm. It is an Open Meeting. We have between 25-30 attendees. Court cards are signed.

Mike K-Sunday AM Serenity Seekers – Our group meets every Sunday morning from 10-11:30 am. We have many long-time members that attend regularly. We celebrate birthdays on the last Sunday of each month. Chapters 3, 5 & the 12 Traditions are read each meeting and chips are given each week for various lengths of sobriety. We currently meet at Lovers Land & Tulare Ave but will lose our meeting building at the end of December and are trying, with little success, to find a place to hold our meeting.
