# "Were entirely ready to have God remove all these defects of character"

#### Step Six\*

On December 3, 2010, I surrendered to the program of Alcoholics Anonymous. I was told that I was going to have to change the way I had been living, and the way I had been thinking, if I wanted to stay sober. I desperately wanted to stay sober. I had tried everything I could think of: will power, religion, psychiatry- nothing worked. A.A. was a last resort for me, so I was willing to do anything that was suggested. A sponsor came forward and began to take me through the Steps. Step One asked me to admit my powerlessness over alcohol. This was easy enough, since my life was a shambles due to drinking. Each subsequent Step asked for more change, and seemed more difficult. This was particularly true of the inventory and admissions in Steps Four and Five. When I arrived at Step Six, I thought I was in for a break...after all, it takes up only one paragraph in the Big Book. How hard could it be? Then I read the essay on this Step in the Twelve Steps and Twelve Traditions, and was surprised. It relates that a well-known clergyman declared that "This is the Step that separates the men from the boys." He goes on to say that one should "repeatedly try Step Six on all his faults-without any reservations whatever." This clergyman was Father Ed Dowling, a Jesuit priest. He had been Bill W's spiritual advisor from 1940, until Father Ed passed away in 1960. He certainly thought Step Six was important. Step Four revealed many levels of character defects that I have: resentments, impatience, intolerance, self-righteous anger...a long list. Step Six requires that

This asks for greater changes, in my opinion, than was asked of me in all of the other steps. The first thing that I had to do was to create an awareness of each defect in my daily actions. My Fourth Step inventory guides me in this. It is a print-out of the harms I have done and the thinking that caused them. Next I had to apply the concept of "acting as if". This means that until my shortcomings are removed, I act as if they are. I can feel impatient with people, but I don't have to tap my foot or constantly look at my watch. It annoys people and has never made anybody move faster; at least not that I can remember. I go through this process with all of my defects of character: know what they are, be aware when they arrive, and rather than be driven by them, act as if they have been removed. The idea is that if I keep doing this, I can make progress towards having them removed. The most important thing for me to remember is that I will be asking God to remove these defects of character. This means that I fully concede that I cannot do this myself and that I trust that God can and will. I must do my part the best that I can. When I am entirely ready, I will call upon The One who has all power. That however, is another Step.

"An A.A. group ought never endorse, finance or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property and prestige divert us from our primary purpose."

I often cringe when this Tradition is read at meetings. This is

because the word "lest" is too often pronounced as "least". The two have entirely different meanings and are not interchangeable. Lest means "for fear that". Least refers to the "lowest in importance or position". I am not speaking, of course, about the readers of this newsletter, who would never do such a thing. I do suggest that if one of our readers hears a newcomer making this error, to counsel him/her in a gentle way.

Tradition Six is in place to prevent the A.A. name from being sold or misused. Most (90%) of the 14,000 recovery facilities in the U.S. use the Twelve Steps of Alcoholics Anonymous as the foundation of their programs. They are free to do this, but A.A. does not grant approvals, licenses or endorsements to any of these facilities. No other business, profit or non-profit, may use the A.A. name in any way. In the beginning years of the fellowship, there were attempts to start A.A. hospitals for recovering alcoholics. They all closed quickly; disputes over money, property and control threw them into chaos. The only thing that A.A. approves for sale is literature, available through the General Service Office. The list of approved literature is short, compared to the mass of recovery literature and products available from a myriad of sources. Get on the computer and one can see everything except perhaps Bill W. and Dr. Bob action figures. (Let me know if you see any. Great gifts for A.A.'s. Birthday, June 10.) A.A. is not in opposition to outside recovery literature, but does not endorse it either. A.A. members are free to read what they like, and buy what they like from whatever source. (However, the Tulare County Central Office is your best bet. It's now open on Saturday, and major credit cards are accepted.)

I went to a 30- day, in-patient program when I first got sober. All of the employees there were A.A. members, but would not state this unless specifically asked. We studied the Twelve Steps and had A.A. meetings at the facility. However, this business did not have the A.A. logo on its website or literature, and claimed no affiliation, approval or endorsement from A.A. Tradition Six states that such places should remain, "well outside of A.A."

There is little doubt that there is money to be made if A.A. would endorse facilities, literature or products. A.A. experience shows that, "...nothing can so surely destroy our spiritual heritage as futile disputes over property, money and authority." So, we stay poor in matters of money, but rich in matters of the spirit and sobriety.

We celebrate AA birthdays on the last Tuesday of the month with either a potluck or a restaurant gathering before the meeting. Cake is served following the birthday mtg.

Jonathan T – Tulare Unity Young People – We meet every Saturday evening at 7:30 located at 220 W. Tulare ave. for a young people's AA meeting. It's an open meeting where everyone is welcome! Please come and join us! Chip meeting and great fellowship.




