You can't go around exposed to the weather, shivering while you wait for the time you can afford a new one. Yes, patch the old thing up and wrap it around you, it will, at least, cover the rags beneath."

When we come into A.A., our lives are just about that threadbare. We clutch our old coats to us, hoping that no one can see through the holes; see the selfish, impoverished little personalities that we are. We have used that old cover-up so long that we are afraid to let it drop. At our first meetings we pick up an idea here and another one there. Patches. We grasp them eagerly and try to incorporate them into the old life.

"We are sick people." All that's fine. A good dose of meetings and a little 12th Step work. "Don't take the first drink." Swell, as far as it goes. But many of us Success Lake Sunrise Porterville, CA Louie T.

hardened sinners have known for years that we were alcoholics and were quite aware of the fact that alcohol in any form was poison to us. Why didn't we stop drinking? Because our personalities were such that we had to have the illusion of warmth that we got from it. We had to feel that we were really remarkable people.

We are not remarkable people. We are, most of us, rather mediocre individuals who couldn't bear the hard work and sustained effort that it would have taken to lift us above this level; flashin-the-pan people, who achieved a small success early in life and have lived on the memory of it ever since.

Throw the old coat away. Patches won't do. We must accept the whole A.A. program, from the 1st Step through the 12th. We must make our moral inventory realistically, from the point of view that, on entering A.A., we were failures in life and were regarded as such in all eyes but our own.

Our new coat may have to be a very plain one. Our new life will perhaps be quite prosaic and humdrum. Well, so be it. It will be far better, far more satisfying to ourselves and those who depend on us than those sleazy old rags of remembered glamour that we hugged about us for so long.

"We admitted we were powerless over alcohol-that our lies had become unmanageable."

When I came into the program of AA, I was told this was the only Step I had to take 100% → with no reservations, What an order! The other Steps I could work on over and over but if I ever thought I could control alcohol, maybe just have one beer, my sobriety -and possibly my life - would probably be over. That I could have just one drink was a lie and I better not believe the lie if I wanted to live.

When I first told my employer (yes! I still had a job at that timee!) that I might have a problem and they sent me to a treatment cener, I had come to the realization that my I was powerless. I couldn't stop drinking no matter what I tried. But. There is always that But. My life wasn't totally unmanageable. I mean, I had a job, a car, an apartment. What was unmanageable about that? I didn't look at the fact that I was behind on my rent, my car payment and paid my utilities when they sent me a 24 hour notice.

Needless to say, I drank again. I completed the 28 day treatment and started going to meetings. Usually daily. I went back to my old life and job. I didn't talk in meetings, didn't have a sponsor and didn't hang around with anyone. I stayed by myself, just like before the treatment center. When called on in a meeting to share, I would say my name, identify as an alcoholic and say I was sober today so doing just fine. I didn't say I was dying lousy inside and scared to death. I would go to work every day, I was an outside sales person so would call on my customers. Sometimes. Sometimes I was too filled with fear to go inside an office. I would sit in my car by a park and read a book. I used to drink but had quit doing that. Needless to say, I drank again. I took a 60 day sobriety chip then stopped by a liquor store and picked up a 4 pack of wine coolers. Within two weeks I had lost my job actually I would guess you could say I gave it away - and had reached total bankruptcy, not the financial kind the emotional kind, in my life. Just like the 12 x

12 says. My bankruptcy as a going human concer was complete, to paraphrase.

I went back to meetings with a complete new attitude. One of total defeat. I was finally able to say more than my name at meetings. I admitted I was powerless over alcohol and that my life was totally unmanageable. I started on the road to sobriety and taking a thorough 1st Step was the start.

I will be eternally grateful that I was morally and physically bankrupt from living the life I had and it left me totally desperate and unable to imagine how I was going to continue living. All I could see if my future was death. Somehow, from somewhere, I got the courage to actually find a sponsor, work the 1st Step thoroughly and start on the road of sobriety.

I am writing this the day after Christmas 2018. Another sober Christmas! My first sober Christmas was 1990 and if anyone had told me what was in store for me I wouldn't have believed them. life has had it's ups and downs but through it all, with the program of Alcoholics Anonymous and a Higher Power in my life, and thoroughly working Step One of the Program, I have been able to stay sober one day at a time. In my opinion, it is only because I worked a complete and thorough First Step.
