

After Her "Willpower" Failed

For several months my drinking habits were becoming steadily worse. I would not give up hope that at some future date I would be able to control my drinking. Somewhere in the back of my mind, I had the idea I would trot out this "will-power" others seemed to have and to put it to work when I needed it. Somehow I had been able to shake it out after a night and day of drinking but this time I didn't seem to be able to face the kitchen stove until I had a drink. Fortunately, there was a little left in the bottle, so while my husband was in the bathroom shaving I took a "quickie". This steadied me enough to enable me to cook our breakfast, mine consisting of black coffee.

As we all know who have traveled this road, along about 10 o'clock the shakes return. I saw no point in suffering. Another "quickie". Needless to say, I ran out of whiskey, dressed and went to the liquor store and returned with a fifth.

It now became necessary to take the drinks more often. By nightfall, instead of having a clean house and hot supper when my husband returned from work I was a drunken object piled in the bed. I had hidden the bottle in the bathroom and all during the night I

would slip in and take a drink. Of course, morning found me a shaking mass of nerves. My husband again left for work with a warning that I must stay sober and straighten up. I didn't know how to straighten up, except by taking a few drinks to quiet my screaming nerves. Naturally the second day duplicated the first, and the third and the fourth, until at last it would only mean death if I didn't get off the stuff. Finally I shook it out with the help of my sister.

This was the first time I had ever been on such a spree. I resolved never to do it again. But I did. Again and again. Each time it became increasingly worse. My hangovers were almost unbearable. There was no happiness when I was drinking. It was simply oblivion. I knew nothing of what transpired for days and then remorse would catch me in its clutches.

At last the voice of my sister penetrated my befogged alcoholic mind. She read to me an article in our local paper—something about an organization called Alcoholics Anonymous. She asked me why I didn't write them. I paid very little attention to her, but after she left I hunted feverishly through the paper for the article to read it myself. I never found it, so thought she must be "nuts".

I decided now was the time to use this "willpower" of mine and at the next party we attended I trotted it out. I took only two drinks the first hour, but goodness knows, that "will-power" of mine let me down. After the first two I wound up as usual—drunk again. This spree ended in a sanitorium. There I heard more about A.A. Thinking that I would contact them, I went home. The humiliation of having to be locked up in a sanitorium to get sober kept me from drinking too much for a month, but Brother Alky caught me again in his trap. It was then I began to believe that I was hopeless.

I at last turned around and faced the woman from whom I was trying to get away. I listened to her say, "You are a doomed woman, you know you can't stop drinking by yourself. You've tried many times but always failed. You're future is black as sin. You will either kill yourself or die in a drunken condition. Your husband is sick of you. Your sister is sick of you; even you are sick of the thing you have become—you must have help."

I tried to pray, but no words came. I felt I had wandered too far from God for Him to hear me now.

Being unable to hold a pen in my shaking hands I asked my niece to write a letter to A.A. for me. This she did with some doubts as to the wisdom of her action. Two nights later, while lying on the couch holding a book before me—wishing I could read and get some sense out of what I read, someone knocked on my door. I now know that knock opened the door to a new world of opportunities. Three women and a man entered, all nice looking people. People who looked like neighbors—but they were different for they were members from A.A. They were alcoholics, they had come in answer to my feeble cry for help.

As I sat there holding my hands to keep them from shaking, listening to them talk, I thought, "They can't possibly know what I've gone through. These people all look happy and healthy, they have not ever been drunks". They soon dispelled this doubt from my mind. They opened up with both barrels and let me have their stories straight from the shoulder.

They then asked me if I thought I was an alcoholic, if I was unable to control my drinking. I reluctantly admitted I was an alcoholic, but was whole hearted

in saying I could not control my drinks. They didn't tell me how to stay sober but they did leave me with literature and an invitation to attend one of their meetings. I very eagerly seized the literature and as I read each story in the booklet, I said, "Yes, that is me. That is me!"

Thus began my new life of sobriety—grateful for any crumbs of wisdom that came my way, thankful to be able to attend the meetings.

I went to my first A.A. meeting resembling something someone had dreamed of in a nightmare. My face and eyes were swollen, I had bruises all over me. I always seemed to have trouble staying out of the way of the furniture. On my last binge the tables and chairs, even the radiators jumped out and hit me, or it seemed. Now in my sixth month of sobriety I can laugh about it, but then I had a hard time forcing myself out to meet people, to expose myself to public view.

Thank goodness, I wanted sobriety enough to go through anything to achieve that happy state, so I went to work on myself, and others. I have emerged from a state of foggy misery, and understand my trouble. I understand that I am afflicted with the disease of alcoholism, that though I can never be cured, I can be an arrested case. With that I am happy. I am free from the desire and need of drinking. My eyes are opened to the need of others. The good and pleasure I receive from helping another is indescribable. I have learned many things through A.A. I am learning something new each day. When the final curtain falls I shall still be learning.

How I have achieved this happy, healthy state, I cannot say. I do know I could not have achieved it without the help of A.A. I do know it is not the mythical "will-power" I once thought I had. It is more than that. It is "Godpower."

Needless to say I am deeply grateful for A.A. For what they have taught me—how to live happily—though sober, a state I once thought impossible. Every day I thank God for the organization and ask only that I may be able to help other unfortunate persons to find their true place in life as I have.

Step Three: Turning it Over -- for Tulare

County AA newsletter, March 2020

Many newcomers to the program are squeamish when they hear Step Three read at

meetings, and I know that I certainly was.

When I came into the program 5 years ago I did not "have" a higher power, though I've had enough mystical experiences over the course of my life to believe one exists. I had been investigating the power of religion for the past decade and thought I knew what that was about, though I was a little afraid that if I really listened to what I was told, I'd find myself carrying a damned cross. But I didn't really think there is someone up in the sky watching everything I do, or that I would qualify for his/her attentions if it did, and I did not want someone telling me I should believe that, regardless.

Red wine had been my go-to buddy for 30 years, and when I came into the program, I didn't really want to stop drinking. But I really did want to stop having my power sucked away daily by hangovers. I wanted to stop being unable to finish anything. I hoped that if I stopped drinking (by some great miracle,) I'd get my power back and accomplish something before I die.

Working the steps with my sponsor, I grudgingly conceded my powerlessness in Step One, reinforced by the clear unmanageability of my life. I blinked at the higher power in Step Two, sure that something exists but still not sure I qualified as a recipient of help. But saying I was willing to turn my life over to this unknown entity I'd just blinked at posed a real problem, and I resisted more blinking or easy answers.

And then, miraculously, even mystically, my sponsor, who had been listening to my heart with her heart for months, found the perfect Third Step prayer for me, called the "Set-Aside Prayer:"

Let me set aside everything I think I know so that I can have a new experience today.

At first I was reluctant to try even this. I am a writer and a researcher, and what I know is my stock in

trade, my livelihood. But I had been using my happy hours to stop a certain kind of thinking that came most often at the end of the day, when I was tired, hungry, lonely from working alone, and often angry at myself if not the world. I had to agree that it was worth a shot.

This prayer was enough to get me to move forward into the dreaded Step Four with significantly less dread. But even better, it was enough to get me to explore relating to a higher power: to practice the art of praying for help when in need, to begin to experience the many blessings that come from not having to know it all or be the one to solve every one of the world's problems. The new experiences started coming, and in turning it over, I made a turn away from the demon of supposed self-sufficiency and toward the truth of community, including the eternal one. It was a turning point: I took a turn for the better.

The only requirement for A.A. membership is a desire to stop drinking

Tradition

The third tradition has a low threshold to becoming an AA member which states, "The only requirement for membership is a desire to stop drinking." So basically, there's no rules that can exclude anyone or keep you out as long as you have a desire to stop drinking. For example: criminal history, emotional/mental health issues, sex, race, color, creed, religion, gender, political affiliation, social status, or any other cultural difference is of

no concern to becoming an AA member. Thank God our founders had the foresight to put into place a non-authoritative approach as well as the principle of non-judgement toward anyone wishing to join our awesome fellowship. However, in my view there's some serious meaning that gets lost between the short form and the long form of the third tradition. The first sentence of the long form states, "Our membership ought to include all those who suffer from alcoholism." Sometimes there is a world of difference between having a desire to stop drinking and a person who's suffering from alcoholism. To illustrate, someone could commit themselves to a low carb diet and develop a desire not to drink based on avoiding carbohydrates contained in booze. Conversely, avoiding carbs in an alcohol beverage is not even in the same universe

as a person who's suffering from the fatal nature of alcoholism. Therefore, I believe that the context in some instances has gotten lost in translation, which has directly attracted people who have entrenched themselves in AA, but don't qualify as the chronic alcoholic in the Big Book of AA (see pages 20-21 of the big book for more detail).

Another point I will note is my experience of coming into the fellowship of AA and having members who expected me to stay sober based on my desire to stop drinking or just attending meetings, implying that I could make it happen by an act of will power alone. However, the BB of AA makes it explicitly clear, "That the most powerful desire to stop drinking is of absolutely no avail" (pg24). In other words, there's a delusion being perpetuated throughout the rooms of AA which is "meeting makers make it" and if you desire to stop "just don't drink no matter what." But coming from the school of having a black-belt in chronic relapse my trying not to drink no matter what and attending upward of 15 meetings a week invariably ended in one failure after another. Finally, after being approached by someone who had a message of depth and weight, I was introduced to the only thing that will help real alcoholics of the hopeless variety, which is a deep and effective spiritual experience. However, it would entail that I would have to meet a series of requirements outlined in the first portion of the Big Book. So, the consideration for powerless alcoholics is this: Is my most powerful desire to stop drinking enough to keep me sober for good? Or do I have "an illness which ONLY a spiritual experience will conquer" (BB pg44).

In my estimation, making clear the distinction of the long and short form of tradition three is of vital importance. I believe it's directly related to the survival of AA as whole; the survival of the AA group; and the survival of the individual alcoholic. Because if there is no AA, there is no AA group, and if there's no AA group--then there's no where for the individual (alcoholic) to go. Ultimately, if AA doesn't survive then many potential alcoholics who might have come to us seeking a solution to their problem will be confined to the tyranny of alcoholic torture. "And with us, to drink is to die" (bb pg 66). My homegroup is an open meeting on Thursday nights (7pm), 526 N. Bridge st. in Visalia, where the focus is the study of the big book. We also study a tradition on the first Thursday of each

month and discuss our experience. We welcome you to join us.

This is a legal issue and there is nothing in the AA program that states that we should protect criminal activity at locations where active AA meetings are being held. We discussed the situation and made no recommendations other than to share at our group business meeting and make policy clear at all meetings. Allen stated the need for an emergency services contact info for health professionals dealing with alcoholics in crises. Also, the Superior Court is handing out outdated AA meeting schedules and we need someone to contact them with proper schedules.


