Sobriety Means Spotting Danger Signals

In 1940 I took my last drink. Naturally I hope I will never take another. But can I be absolutely certain? No, because I do not believe that I can ever accept my sobriety as an accomplished fact. Yet, neither do I mean that I am, as in the early days of it, haunted by the fear of returned drunkenness. Then it was a ghost always with me, casting its dark shadow across the way. What if the old pattern reasserted itself? What if I did get drunk? I, who wanted so desperately to stay sober!

I thought much and with concern about it, and then one day, quite unconsciously, my son gave me what has seemed to have been my answer. He was a boy of 10, captain of one of those little boy football teams that play the game so very enthusiastically and with such very bad results. His heart was set on winning the game against the school's great rival. As the day drew near I asked him how things were going and what the chances were. Earnestly be looked at me and said, "It's a funny thing, Mummie, they all want to win the game, but they don't want to practice!"

Instantly it struck home! Had I wanted to win the game of sobriety without realizing that to do so would depend entirely on my own willingness to practice

regularly those things in which mental sobriety has its origin?

A certain pattern of physical sobriety had been established. There was no longer a definite physical urge to take a drink; but what about mental sobriety? From then on I began to think much less about a physical slip and much more about a mental one. I lost the fear that I could "catch drunk" as I could "catch cold." In its place developed an awareness that if I remained mentally sober, I would never find myself physically drunk. This became a firm conviction and has remained one ever since.

I determined to recognize all subversive thoughts. What better sign, for instance, that I am going off the A.A. track than to start feeling sorry for myself? That "nobody loves me" feeling and its companion, "no one really understands me." Or the pressure signal. Here is a world to be remodeled. I, and I alone, must do it, and that immediately or at the most within two weeks. Just as when the intolerance signal flashes. Then indeed must I be on the alert for when I start worrying about another's failure to practice the 12 Steps I can be quite certain I have mislaid them myself.

No stranger, either, to my impulses, is the one which prompts me to believe that I have never been fully appreciated; that circumstances have cruelly diverted genius into mediocrity, that old ego aborting the truth. Nor does it stop there. It invariably leads to a sense of self-importance that is translated into terms of my wanting to play God. In my own life and the lives of others I want to be the director. How smoothly The show would go off, if only I was allowed to manage it all! This feeling is often directed primarily against the group—that intractable, obstinate body of men and women who surely, after all, do need me more than I need them. When this happens I know definitely that it is time for me to act.

For me, it is not enough to merely recognize these danger signals. I must take action against them. This I find can best be done by doing immediately some A.A. work. Any one of a dozen ways may suffice, but the one which so far has not failed is getting myself to an open meeting. Taking the attitude that it is my first meeting, I try to clear my mind of all that I have previously known about A.A. and open it only to what I do not know. That I shall never know much, can never feel myself to be immune, or as not needing daily practice in The 12 Steps, becomes plain. I am once more impressed with the need for and greatness of A.A.

Back on the scrub team I am content to let someone else call the plays, certain that if I respond with my best efforts, A.A. will through its program, give to me in return a deep, rich assurance that I need never take another drink.

Made a searching and fearless moral inventory of ourselves.

Step 4 was a major step forward in my life. It represented actually getting real with myself for the first time in my life. I am such a good liar and manipulator that I could lie and manipulated myself into being OK with a

bunch of really terrible things. To get ready for step 4 (this is by no means the "CORRECT" way or only way, just the way I did it) I conducted a reading, with my sponsor, representing each of four areas: resentments, fears, sex conduct, and harms. I was provided a worksheet one at a time.

First, I got the resentments worksheet. My sponsor made me give him a deadline when I would be finished with the first part. I sat down with the resentments worksheet and a prompt list and started on the task at hand. I got all of three resentments done and I hit a wall.

I called my sponsor and told him I was stuck and I couldn't think of anything else. I was politely told that I was full of crap, and that I was being selfish, unwilling, and letting fear run my life. I was told that if I wanted any relief from my condition that I had to practice the spiritual principles of the program of Alcoholics Anonymous, belief in the power of God, plus enough willingness, honesty, and humility, in all of my affairs; including the 4th step! I was told I had to dig and dig deep. God can move mountains, but I had to bring the shovel!

I prayed for humility to see my part in every situation, honesty, and real willingness. I was truly desperate and willing! My sponsor taught me that if I <u>really</u> wanted a new life I <u>really</u> had to do the work to the best of my ability.

A miracle happened. I was granted that willingness and I completed the deepest most comprehensive 4th step I possibly could and it set me free, finding God, digging deep down, and using those spiritual principles set a bar for the rest of my life. It opened a door in my heart that I never want to close!

Step 4 is a vital step and I encourage everyone to find someone they can truly trust and abandon themselves on the program and the spiritual principles. I can promise you if you do the work and trust God, then your life will improve. There will be feelings and thoughts that come up, it will be uncomfortable, but it will change your life. I love this program and I love all of my brothers and sisters in sobriety!

Iradition 4

Each group should be autonomous except in matters affecting other groups or A.A. as a whole.

If I were trying to paraphrase, explain, or simplify the language of the Fourth Tradition, I'd say that each group can run itself any way it wants as long as it makes sure that when a newcomer shows up looking for sobriety, he or she will find the program of Alcoholics Anonymous.

We have the Twelve Steps to guide our recovery, and we have the Twelve Traditions to guide our groups. We also have the Twelve Concepts for World Service to give voice to our collective group conscience and to organize and guide our participation in AA World Services and other A.A. service entities.

Our Twelve Traditions came out of the formative years of Alcoholics Anonymous and the threats to A.A. unity that confronted our early groups. I find it amazing that the idea of "top-down" authority for A.A. was rejected in the creation of our Traditions—what an inspired stroke of genius! Tradition Two says, "For our group purpose there is but one ultimate authority—a loving God as He may express himself in our group conscience. Our leaders are but trusted servants; they do not govern." This is where the wisdom is acquired to mindfully observe Tradition Four. It is the group conscience that sets the standards and policies for our individual groups, but an informed group conscience requires guidance from our Steps and Traditions. Emotions, egos and prejudices are the greatest threats to our unity, but they can be miraculously diluted and disarmed within a group conscience that is predominately rooted in our Twelve Steps and Twelve Traditions.

This is what I find so amazing. What seems to be a vacuum of organizational authority and leadership actually seems to minimize the opportunity for chaos and corruption. I cannot remember a single argument or debate in an A.A. business meeting where the issue didn't ultimately find its resolution in what was right for the fellowship or how that decision aligned with our Twelve Traditions. It seems that our debates focus on "what's right for all of us," and very rarely on "what's best for me."

So every group is free to run their meetings as their members wish, but each of us has the responsibility of becoming familiar with our Twelve Traditions, so that each of us can participate as part of a well-informed group conscience. If we stick to our primary purpose, observe our public relations policy and seek guidance from our ultimate authority, there is little chance that our autonomous groups will adversely affect other groups or A.A. as a whole.

A word from our Webmaster

I wanted to go over a few changes I have made to the web site. With the events to get through the COVID-19 pandemic, it was clear that we needed to quickly set up a way for our members to find meetings on-line. Simultaneously, the member in Silicon Valley who maintains the program we use, made changes so that finding on-line meetings is easier, and getting to them is easier.

We now have a new menu item at the top of the web site: "Online Meetings". That shows a page of every online meeting we have. As of his writing, there are 25.

The home page of the web site has three changes on it.

At the very bottom is a "form" where you can let us know about a new online meeting. We do need some sort of link and telephone number to put in; the program doesn't let us add a meeting without a link and a phone number. If you include your email address, I can let you know.

The next change is that the home page has a list of the next five meetings that are coming up. It will change with the time of day.

The last change (but it is at the top) is a "recent posts" link. This is where news or announcements will be, that don't really fit in the category of an "event" or a "meeting".

The menu up top on the web site also now has an item: "Online Meeting Etiquette: Zoom Tips & Tricks". I just pulled in some text that members have written about online meetings in general, and Zoom in particular. Thank you very much to Bill H. for much of that source content.

Two more notes about meetings on the web site, and in the Meeting Guide app for your smartphone.

First, the Meeting Guide app is rather wrong right now. It is not maintained by the same people who maintain the program we use for our web site. The result is that there is a disconnect between the Meeting Guide app and the web site. So, if you are in the Meeting Guide app, but you see "IMPORTANT: " listed below, then you can safely ignore the red lettering that says this meeting is temporarily not meeting. The meeting is meeting; but the building where the meeting was, is now (temporily) closed.

The other thing about the Meeting Guide app is that it does not let you click on links that we just put into meetings. This is an Internet safety precaution; but, it also means from the Meeting Guide app, there are two more extra steps to

go through. Say you've found a meeting (in the app) that does have an online version. You need to scroll down to the button "View Web Page". Push the button. It will take you to our web page for the exact same meeting; but, the web page DOES have a clickable link to launch Zoom or GoToMeeting or Discord or whatever. So today, it's a three step process. Find the meeting in app, then visit the web page the app sends you to, and then click the Zoom icon (or whatever) to launch the Zoom app.

before they arise can help a group be prepared to address them in a sensible and helpful manner and allow the group to continue keeping the focus on our common welfare and primary purpose.

Some groups have discussed making changes to customs at their meetings. Some examples have included: avoiding shaking hands and handholding; making sure meeting hospitality tables are sanitary; or suspending food hospitality for the time being. Regardless of group decisions, each individual is responsible for their own health decisions.

Some groups have considered contingency plans in case the group is temporarily unable to meet in person. Plans have included: creating contact lists and keeping in touch by phone, email or social media; meeting by phone or online. Providing members information for the A.A. Online intergroup (www.aa-intergroup.org) may serve as an additional helpful resource. If a group isn't holding its regular meetings, they may want to communicate this to local A.A. resources, such as the district, area and intergroup or central office.

G.S.O. has received inquiries about the A.A. events it coordinates throughout the year. Visit www.aa.org for up-to-date information regarding G.S.O./A.A.W.S. coordinated events. Please be assured that the health and safety of attendees is a priority. G.S.O. is closely monitoring relevant health advisories regarding COVI D-19 (coronavirus).

The bartender asks him why he keeps pouring out the first shot all over the bar.


The alcoholic replies with "My AA group said all I need to do is avoid that first drink."
