## Do You Know: That your Candor is Contagious

I've been in A.A. for two years and during this time 1 have told hundreds of people about it. As a write r it is my business to know all kinds of people. As an individual, it is my pleasure to do so. 1 have friends and friendly acquaintances of all ages, backgrounds, religious creeds, and types of education. People in every imaginable occupation from cook to Cabinet Member. Also, in these two years, I have met countless strangers, made endless new acquaintances. Whenever the subject has come up, I have said that I don't drink any more. And if people have shown any interest, I've told them all about A.A. But in all this time I have had only one hostile reaction, and that was from a woman who is now considering A.A. for herself.

My reasons for talking so freely are several. First (but not the most important) is my own selfish reason. 1 am so relieved, so glad to say I am an alcoholic. To know why I was sick, to know that I am not immoral, evil, or crazy. I am so glad to be able, to go back to those people before whom I got drunk in the past, before; whom I behaved badly, and be able to say: Look. I am an alcoholic. That's why I acted the way I did. Now I don't have, to get that way anymore. For this load is now lifted. This awful load of shame, fear and guilt. Instead of avoiding people's eyes, instead of wondering what they think of me, instead of

crossing the street when I see them coming, I can keep on walking down the street, say hello, shake hands, and smile.

My other reasons stem from this one, and yet they are more important reasons. For I feel that my own unembarrassed attitude, my own frankness and freedom in the matter, affects everyone with whom I come in contact, and with whom I talk. Freedom from guilt and embarrassment is the only altitude that we alcoholics can have. If we want to "forget" about our drinking and conceal our past and pretend or wish we weren't, in A.A., then we have not yet forgiven ourselves. It is highly important that we forgive ourselves, utterly, or others won't forgive us. They will continue to sense in us shame and fear. Then they in turn will feel uneasy. They will continue to think of the subject as a moral issue, censurable, objectionable. We must be ready to say to people what we say to ourselves. That our past is our sick behavior, and that our present and our future is our convalescent and our well behavior. That we are living from day to day, in our new present, which is our strong secure future, forever. Herein lies all the hope of our lives. I think that this altitude within ourselves is most contagious. Over and over I have heard from other A.A.s how they have, gone to a frightening boss, and talked

to him, only to find him friendly and helpful. How they have won over stiff-necked relatives, or a narrow-minded community, in the most magical and wonderful way. For seldom does anyone, lose a job, a friend, the esteem of his neighbors because of not drinking. It is drinking and getting drunk that bothers friends, relatives, neighbors. And even this is being looked on with more and more understanding, thanks to the frank attitude of the average A.A. For the more people learn about A.A., the more they understand what alcoholism is, the more lenient they become toward the alcoholic and his problems. And the easier it is for the alcoholic to shed his fears and face himself.

I found like a bushel of sweetness and light. Alas, I am fa r from that. There are plenty of people around these United States (not to say a few in Europe) who hate my eyeteeth and wish I were pushing up buttercups this very minute. I have not gotten them all to forgive me. I'll be doing well if I get half of them to do so before I'm through. Yet I think that as I progress in A.A., I will be able to get a few of them to realize that I'm not responsible for what I did then. That I am trying, to the best of my ability, to make amends, through 12th step work, and in all other possible ways, and that I, like everybody else, who is working at A.A. have undergone a change that is a miracle.

This brings me to my last reason for telling the world. When 1 say to friends and strangers, I'm an alcoholic, I belong to Alcoholics Anonymous, I am saying something wonderful, something good. I am saying, Look at me now. Look at what I was. Maybe I'm not much now. But 1 am well. 1 am happy. Happier than I've ever been in my life. I am no longer scared to death. I can work. I can love people. I have hundreds of new friends who understand what I went through because they went through it too. I am no longer lonely, and alone. From being a dead weight, and useless, I have, become of great use. Not because of myself as an individual, but because of what I'm a part of. For this thing I'm a part of is one of the grimiest things this world has ever seen. Hope, and belief in the goodness of people, and love. In this present world, where we are living in the precarious shadow of our mistakes, is it not wonderful to belong to a thing like this? I'll tell the world it is.

Admitted to God, to ourselves, and to another human being the exact nature of our wrongs.

Step five was a source of anxiety and fear for me as the time came to read my resentments out loud and acknowledge my part in them.

This was not only because I was afraid to see my part, but because I felt shameful about my actions while in a drunken stupor. The shame that I carried led me to believe that I didn't deserve to have resentments to fifth step with my sponsor.

She soon sent me back to the work to drudge up my true feelings and in fact I did have feelings of resentment buried deep within. After understanding my shame tricked me into thinking I had no resentments I saw that confessing my sins to god and another human being was vital to my sobriety.

My fifth step with my sponsor was rough. I didn't want to reveal the things that made me recoil from my self. I wanted my sponsor to like me. I didn't want her to see my ugly past.

Interestingly enough revealing the darker sides of my self brought us closer together. Being transparent and vulnerable with her was the very thing that I needed to do at the time.

"More realism and therefore more honesty about ourselves are the great gains we make under the influence of step five" as quoted from the Twelve and Twelve step five. This quote speaks to my soul. I made great gains in my fifth step.

I love myself today. In return I am loveable.

# Tradition 5

Each group should be autonomous except in matters affecting other groups or A.A. as a whole.

This tradition seems simple enough. The reason we have group meetings is to carry the message to suffering alcoholics, and in so doing, stay sober ourselves. Let's take it apart a little bit. The Tradition starts with "each group". We know what a group is; Tradition Three tells us: "Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as

a group, they have no other affiliation." So our two or three drunks cannot be allied with a particular religion, or political philosophy. The groups message has to be about recovery from alcoholism only. However, the long form of Tradition Five states that "Each Alcoholics Anonymous group ought to be a spiritual entity..." We must know and recognize the difference between spiritual and religious. This border can be difficult to see sometimes, given that there are references to Christian concepts in the Big Book of Alcoholics Anonymous. Even the concept of what constitutes a meeting is found in another, older book. (whenever two or more are gathered in My Name...) Tradition Five urges us to stick to our message of recovery from alcoholism through the Twelve Steps and not cross over the line to preaching any religion.

The Tradition specifies that the group is to carry "its" message to the alcoholic who still suffers, as opposed to "the" message or "A.A.'s" message. This suggests that there could be a difference. There are many different types of specialized meetings in A.A.: step studies, book studies, 10th step groups, newcomer groups, speaker meetings among them. Tradition Four states that "each A.A. group should be responsible to no other authority than its own conscience." It is up to each group to decide what its message is within the framework of the suggested Twelve Steps. To ensure that the group is fulfilling its primary purpose, we are provided with a tool: The group inventory. As an individual alcoholic, I use the tool of moral inventory to clear the way for a spiritual awakening. As an A.A. group, we can use the inventory to evaluate how well we are fulfilling our primary purpose. I am a member of two groups which are presently in the inventory process. We will examine each of the Twelve Traditions, to see how well we are practicing each of

these principles in our group. As individuals, we have a Tenth Step to keep us in balance each day. Periodic inventories can do the same for the group. A suggested plan for a group inventory is contained in the A.A. pamphlet, "The A.A. Group...where it all begins" The pamphlet is available at the Tulare County Central Office in Exeter, and at a cost of 10 cents, you may never find a better deal. You can look though, because the Central Office has a terrific selection of A.A. literature to meet all your recovery needs: books, chips, pamphlets, cd's and much, much more.

## A word from our Webmaster

I wanted to go over a few changes I have made to the web site. With the events to get through the COVID-19 pandemic, it was clear that we needed to quickly set up a way for our members to find meetings on-line. Simultaneously, the member in Silicon Valley who maintains the program we use, made changes so that finding on-line meetings is easier, and getting to them is easier.

We now have a new menu item at the top of the web site: "Online Meetings". That shows a page of every online meeting we have. As of his writing, there are 25.

The home page of the web site has three changes on it.

At the very bottom is a "form" where you can let us know about a new online meeting. We do need some sort of link and telephone number to put in; the program doesn't let us add a meeting without a link and a phone number. If you include your email address, I can let you know.

The next change is that the home page has a list of the next five meetings that are coming up. It will change with the time of day.

The last change (but it is at the top) is a "recent posts" link. This is where news or announcements will be, that don't really fit in the category of an "event" or a "meeting".

The menu up top on the web site also now has an item: "Online Meeting Etiquette: Zoom Tips & Tricks". I just pulled in some text that members have written about online meetings in general, and Zoom in particular. Thank you very much to Bill H. for much of that source content.

Two more notes about meetings on the web site, and in the Meeting Guide app for your smartphone.

First, the Meeting Guide app is rather wrong right now. It is not maintained by the same people who maintain the program we use for our web site. The result is that there is a disconnect between the Meeting Guide app and the web site. So, if you are in the Meeting Guide app, but you see "IMPORTANT: " listed below, then you can safely ignore the red lettering that says this meeting is temporarily not meeting. The meeting is meeting; but the building where the meeting was, is now (temporily) closed.

The other thing about the Meeting Guide app is that it does not let you click on links that we just put into meetings. This is an Internet safety precaution; but, it also means from the Meeting Guide app, there are two more extra steps to

go through. Say you've found a meeting (in the app) that does have an online version. You need to scroll down to the button "View Web Page". Push the button. It will take you to our web page for the exact same meeting; but, the web page DOES have a clickable link to launch Zoom or GoToMeeting or Discord or whatever. So today, it's a three step process. Find the meeting in app, then visit the web page the app sends you to, and then click the Zoom icon (or whatever) to launch the Zoom app.

before they arise can help a group be prepared to address them in a sensible and helpful manner and allow the group to continue keeping the focus on our common welfare and primary purpose.

Some groups have discussed making changes to customs at their meetings. Some examples have included: avoiding shaking hands and handholding; making sure meeting hospitality tables are sanitary; or suspending food hospitality for the time being. Regardless of group decisions, each individual is responsible for their own health decisions.

Some groups have considered contingency plans in case the group is temporarily unable to meet in person. Plans have included: creating contact lists and keeping in touch by phone, email or social media; meeting by phone or online. Providing members information for the A.A. Online intergroup (www.aa-intergroup.org) may serve as an additional helpful resource. If a group isn't holding its regular meetings, they may want to communicate this to local A.A. resources, such as the district, area and intergroup or central office.




