I've stopped dreaming now. I found the truth in Kipling's poem, If, in the line that reads: "If you can dream and not make dreams your master." For years dreams led me far afield, aided and abetted by alcohol. The aura of bigness was my secret companion — my mate in loneliness. I dreamed of wealth — of title — of happiness — and I became lonelier.

As I did it, I became more the willing and obedient slave of alcohol — of course not knowing what was wrong with me. I blamed everything on my loneliness — self-pity because not a soul wanted anything to do with me or would have anything to do with me, except the habitués of the bars. I was alone — with the boon — the solace — the conniving fixer of all loneliness — alcohol. That is what I thought then.

I could not face tomorrow because I knew today's dreams would not come true. Yesterday's had not materialized so how could I expect today's would come true tomorrow? But I kept on dreaming any way. It was fun — or so I thought. Maybe it helped me cling to that bit of sanity I had to retain if I were to circulate among normal folks with whom I came in contact in a vague sort of a way. I don't know — and I really don't dare now.

But it was a year ago when I wound up what I like to

think of as my last swirl in the whirlpool. I was Mr. Big Shot for three weeks. Of course I ran out of money, but that didn't matter as anyone in A. A. knows. I borrowed to the limit. My "credit rating" was excellent in all the local bars. From all my "friends" — the bartenders — I secured funds to continue my dizzy whirl. They admonished me with "Why don't you stop this? You are too nice a guy to be doing it." They were well-meaning, no doubt. But they let me have what I wanted when I needed it.

But I was still dreaming. I was a different person in every town which I visited. I ran the gamut of occupations.

That I could talk, either sensibly or insensibly, was due, I suppose, to the fact that I had 20 years of newspaper experience in back of me. Oh, yes, I was impressive. I could cite facts, figures, places, and important people, whether I knew them or not. I was Mr. Big Shot. But I was still dreaming.

Today I don't dream any more. I think of tomorrow in terms of yesterday. That is, I know I can't correct today what I did wrong yesterday so why should I worry about the mistakes I might make tomorrow? But I always had. I had never heard of doing anything else but that, until I came into A. A. Now I am learning how, and willing

to learn more. I am trying to make today's foundations as firm as possible so that tomorrow I won't have any regrets.

A simple formula, in effect, but difficult for most of us to grasp because we are re-educating ourselves on how to live, whether alone or with others. I don't have that loneliness any more because what I am doing today is something concrete and worthwhile for me — and others. I have no time to dream as I once did, because the things I am doing or planning to do will affect someone beside me.

The dreams are no longer ethereal, alcoholic inspired visions. They are plans — not hallucinations of how big I am — how good I am — how I am the Great I Am!

A. A. and its gentle but persuasive method of rehabilitation gives you an appreciation of life without the fanfare — without the promises you never keep and could not keep — without the ostentatious show of ego.

You are now a segment of a sane and happy group of people who are getting a value from life for something given. You no longer try to take all — you no longer do it alone — you've lost self-pity — self-centeredness. You are no longer selfish. You are selfless.

We humbly ask God to remove our shortcomings

So, what is a shortcoming and how do I know what mine are. Sometimes these are harder to spot then you might think and unfortunately, they often are brought to the surface through painful experiences. In fact, the really good ones are hiding in our resentments. But I thought that's where other people had hurt me! It is! However, the Big Book says that our troubles were of our own making and that by acting out in selfish ways I had unintentionally hurt others or had at least placed myself in a position to be hurt. This is another reason that the inventory process is SO important. Not only am I going to face and be rid of the things that were blocking me off from God (resentments) but I am to discover the "weak items in stock." The weak items in stock are my shortcomings. They are discovered in the fourth column of resentment inventory when I

put out of my mind the harm that others had caused me and look around the entire relationship at where I had been selfish, dishonest, and fearful. For example, when I was a newcomer, I used to have very little filter when I talked, and I had a very extreme and attitude and sense of humor. I didn't see anything wrong with this and maybe there is nothing inherently wrong with it but I began to see through writing resentment inventory that when you carry yourself this way, some people won't take you seriously and may try to play you or take shots at you "for no reason." Putting out of my mind the harm that they had done, I saw that I was being selfish by acting extremely around others and that I probably had a fear of being not good enough or not being liked. So, this became a weak item in stock. Another example is that my whole life I had been a big-time avoider. I would always avoid uncomfortable situations and uncomfortable conversations at all costs. Then I began to see that uncomfortable situations cannot be avoided! They always come back around, and they usually hurt more when they do. Someone will begin questioning me about something I didn't do or was trying to not talk about and by now they have lost some respect for me because I was trying to avoid it. Then I resent them, but didn't I place myself in a position to be hurt by being an avoider. Another weak item in stock. Another is thinking I'm better than people or shunning people or presuming to make decisions for other people. So, these are the flaws in my make up that I take to God in Seven. With any character defect I take to God I first ask myself: Do I find this objectionable? Can I see that I can't be anything different on my own power? And am I willing to turn to God in this area? Once I ask God to remove it the book suggests that I might discuss it with someone. I do this when it is something that is particularly objectionable or shameful or something that has a real stronghold. This is an exercise in humility which may be necessary to receive the grace from God that I need to overcome this problem. As we use these practices things change! Character defects are removed, and the needed power comes! Before long we realize that we are in uncharted territory and living a life that we knew had to be possible, but we had just never been able to figure out how. God was the solution! We needed a practical program of action and we found it in the twelve steps.

Tradition 7

The AA group usually starts small and gains momentum as the message of recovery becomes attractive. The AA members begin to attend on a regular basis and the attraction comes from the principles of recovery. The members become committed to supporting the group financially and responsibly by meeting obligations such as paying rent for the meeting space, buying literature, financially supporting trusted servants to attend out of town business meetings in addition to buying coffee and supplies which encourage a hospitable environment for the newcomer.

Self-support which does not cost a penny might also include the someone to open the meeting room, set chairs in place and put literature in an easy to reach place. This requires consistent commitment on the part of members. The stability of the group and meeting rests on such commitment.

What happens if a group cannot meet financial obligations? Should there be a fundraiser, a yard sale, a car wash or some other means of making money? Tradition 7 cautions us to understand what it is we need versus what we want. It is important to remember our primary purpose is to carry the message. We do not want to stray from our primary purpose by getting into a controversy over how money is raised where it came from and who will control it. The best solution is voluntary contributions from AA members themselves. Sometimes in bleak financial times, the members may have to consider an increase in their donation to the meeting. A group might have to examine their expenses and trim their budget to meet the needs of the group.

The Seventh Tradition encourages the group to support itself. It is important that the group not become financially dependent on an outside entity or one group member. Each member of the group is a part of the great whole and in turn, each member of the group has an obligation to help support the group financially. One or two group members who are financially well off should not be expected to support the group and do all the work. Everyone does their part.

The spiritual principles of Tradition 7 are gratitude, responsibility, faith, anonymity, integrity and freedom.

It was inspiring at our H&I Committee Meeting June 13, 2020, to learn how our volunteers have found ways to bring the A.A. message to the confined alcoholic in the midst of these unprecedented times. Mothering Heights began zoom H&I meetings in May, which have now expanded to bi-monthly and include New Visions and New Hope. This is scheduled to continue until the end of July when it will be determined if in-person H&I Meetings can safely resume. Pine Recovery attempted to begin zoom H&I meetings and had five volunteers waiting for Pine to join the zoom format. Unfortunately, Pine was unable to join due to technical difficulties. The volunteers are now working on structuring outside H&I meetings for the residents of Pine. Our Mental Health commitment will resume H&I meetings on July 2nd and is in the process of expanding to bi-monthly meetings. Turing Point, Tulare County Jail, Corcoran Prisons and Avenal Prison, continue to remain closed and virtual meetings have been suggested but were unable to be accommodated. The confined alcoholic in these facilities have continued to receive A.A. literature provided by contributions to the Pink Cans. It was approved to pursue taking H&I meetings to Hanford which has remained dark for several years. As our Regional Chair position is vacant, we had representatives from Area 91 Madera/Mariposa, Spanish Region 190, and a report provided by Area 92 Fresno in order to maintain open communication and unity in our Region. We actively participated in the 2020 proposed policy revisions to the Pink Pamphlet by discussing the revisions and having representatives from our Area and Region participating in the Northern California Hospital and Institution General Committee Meeting, which is the deciding body of our service committee. The guidelines are being put in place to bring the IVSS Program, which started as a pilot program at San Quentin and afforded inmates in person sponsorship, to other Major Institutions. The Grapevine June Annual Prison issue this year, features our IVSS Program on the cover, it is worth checking out! Remember, by contributing to the Pink Can, we are all a part of this historic program being rolled out! The ability to continue to carry the A.A. message to the confined alcoholic is due to the generous contributions to the Pink Can, we are grateful and blessed by the

generosity of A.A. Members in Northern California.

At our August 8, 2020 9:00 a.m. meeting, we will vote on moving our meetings to the 4th Saturday of odd months at 10:00 a.m. with H&I orientations on the 4th Saturday of every month at 9:00 a.m. at the Visalia Alano Club. The proposed change will afford time for our committee to review information from our Steering Committee and continue active participation at the General Committee Meetings. Another topic we will discuss, is the proposed Area Reimbursements as some Areas are struggling to maintain rent to hold their H&I Committee Meetings. Please send your group representatives to our meeting to vote your group's conscience on our committee's decisions. We hope to resume meeting at the Visalia Alano Club July 18, for orientation, but will monitor the health restrictions and update the meeting information available at www.aa-tulareco.org. We will continue posting our agenda and minutes in the meeting tab of our committee meeting information prior to the Committee Meeting, please check back often.

It is a blessing to be in-service with you all and carry the message to the confined alcoholic in unity.
