

Cultivating Tollerance

During nine years in AA, I have observed that those who follow the Alcoholics Anonymous program with the greatest earnestness and zeal not only maintain sobriety but often acquire finer characteristics and attitudes as well. One of these is tolerance.

Tolerance expresses itself in a variety of ways: in kindness and consideration toward the man or woman who is just beginning the march along the spiritual path; in the understanding of those who perhaps have been less fortunate in educational advantages; and in sympathy toward those whose religious ideas may seem to be at great variance with our own.

I am reminded in this connection of the picture of a hub with its radiating spokes. We all start at the outer circumference and approach our destination by one of many routes. To say that one spoke is much better than all the other spokes is true only in the sense of its being best suited to you as an individual. Human nature is such that without some degree of tolerance, each one of us might be inclined to believe that we have found the best or perhaps the shortest spoke. Without some tolerance, we might tend to become a bit smug or superior— which, of course, is not helpful to the person we are trying to help and may be quite painful or obnoxious to others. No one of us wishes to do anything

that might act as a deterrent to the advancement of another—and a patronizing attitude can readily slow up this process.

Tolerance furnishes, as a byproduct, a greater freedom from the tendency to cling to preconceived ideas and stubbornly adhered-to opinions. In other words, it often promotes an open-mindedness that is vastly important—is, in fact, a prerequisite to the successful termination of any line of search, whether it be scientific or spiritual.

These, then, are a few of the reasons why an attempt to acquire tolerance should be made by each one of us.

Why is admitting we were powerless over alcohol - that our lives had become unmanageable, so difficult for so many of us to accept? This is where the road to Happy Destiny begins! But finding the road takes what it takes.

You see, before I began my journey, I firmly believed that strength came from will power, and asking or

needing help was sign of weakness. Sure I drank a lot, but you would drink too if you life was as difficult as mine. Besides a few mishaps with the law, I still believed I was in control. I had a brief experience in AA and could only see how I wasn't an alcoholic.

My drinking progressed just as the book says and eventually all the justifications, the self pity, and the resentments took their toll. Finally the day came that I wanted to stop drinking. But I could not. I remember thinking "how did I let it get this far, I'm stronger than this", but phenomenon of craving was in full works. I made countless vain attempts to moderate my drinking. Even after defeat after defeat, I still would not admit I couldn't do this on my own. Needing help would mean I might lose everything. Fear ruled my thought and I felt trapped, until it happened, "A moment of clarity."

I was sitting outside at work looking out the shop door and for the first time admitted to myself I was powerless and my life was a total mess. Without help I was going to die. Desperation set in and I sought out help. In this act of humility I gained hope.

This time when I went to an AA meeting, I heard a message and it was clear. I got a book, found a sponsor, and discovered, that admitting I was powerless over alcohol-that my life had become unmanageable was the first and most important step in recovery. Without it little else could have been done for me. But, this was only the beginning. There was much more work to be done.

Today, I now realize that it takes far more strength to ask for help than to rely on self will. I am truly grateful for the Fellowship and the many blessing I experience each and every day. The road hasn't always been easy, but I know and enjoy a life far better than anything I could have expected. Fear may have brought me in, but love keeps me today.

At the end of page 164, the Big Book says," And you will surely meet some of us as you trudge the Road of Happy Destiny. May God bless you and keep you-until then."

The road begins at step 1.

WEBSITE REPORT: David--For the web site report, please note that for the 30 days ending December 8, 2020, we had 3,187 visits and 639 unique visitors. Bob H. had made the correct observation that previously, we tracked "page views" instead of "visits". A visit is a group of page views within a 30-minute time span. For completeness sake, these last 30 days we had 7,386 page views. This month's activity is pretty similar to last month's. Also note that meetings are not keeping up with their meeting status as to whether or not meetings are active.

H&I REPORT: Joyce R.--At our November 28, 2020 meeting, we reviewed our past fiscal year. In the midst of the pandemic shutdown which occurred in mid-March, we were able to begin zoom H&I meetings in May at Mothering Heights; September at Pine Recovery and November at Turning Point. While the Mental Health Facility and Tulare County Jail continue to remain closed. Zoom technology has afforded us the opportunity to still bring 57 meetings to the confined alcoholic utilizing 66 volunteers in the past year. We had a presentation from Jason C. CNIA Area Chair for Bridging the Gap. We will be available to the extent possible to assist in introductions to the facilities and once the facilities are associated with Bridging The Gap, we can leave their cards at the meetings we facilitate. We elected a new Area 93 Chair, Boo M. We are very excited to have Boo step into this position. We also voted to recommend Joyce R. as our Regional Chair candidate which will be brought before the other Areas in our Region for a vote. As of December 8, we were notified that the Spanish Region 190 has changed their leadership team. Boo, contacted Rafael F. the past Spanish Regional Chair. Rafael has agreed to hold the Spanish Speaking Chair Position with Area 93. Rafael is motivated to attend our local Spanish Speaking meetings and attempt to encourage them to volunteer in H&I This will afford the opportunity to bring H&I meetings to the Spanish Speaking confined alcoholics. We are very grateful to the Tulare County A.A. fellowship who continues to pass the Pink Cans at meetings. Together we are able to reach the confined alcoholic. We thank you all!

Bridging the Gap: Jason is the BTG representative for CNIA (California Northern Interior Area) and he reported that he has a volunteer (Jonathan T) for Bridging the Gap for District 47, and they are looking for more male and female volunteers to be involved that are interested in helping out. BTG helps people being released from treatment facilities, out-patient facilities and the like who are met by BTG volunteers who help get the people to their first AA meeting, give information about contacting AA and let them know how to get plugged in to AA. H&I Report: Ralph D. reported that as November is the end of our fiscal year, we are excited to report that even in the midst of facility shutdowns, we were able to bring 57 H&I meetings utilizing 66 volunteers to the confined alcoholic.
