

A word to the Wise

As the wife of an alcoholic who suffered through years of unhappiness because of my husband's affliction, I took to A.A. perhaps even more avidly than he did when we first heard about it. I entered into all the activities, subscribed wholeheartedly to all the precepts of A.A., and thought I was helping my husband to the fullest.

This winter I had to come out here from our home in Illinois because of my own health. It has been my first trip away from my husband for many years, and being alone I've found that there are several lessons in A.A. for us wives.

To me, one of the most insidious thoughts that has dominated the attitude of a wife who has stuck through all the trials and tribulations of a drinking career is the self-pride and nobility on which vanity feeds so copiously. I was never conscious of it, actually, and really meant it when I said that I wanted Jim to recover from every bit of the illness; I wanted him to be independent, sufficient in himself, and wanted him to do the thinking for the family. When he started up the long road, and signs of the emotional changes in him became evident, I was delighted. It wasn't until I got away from him, and had to relinquish my mental attitude of supremacy, that I realized how that had built up over the years, and what a large part of my subconscious it occupied!

Jim is more than grateful that I did stick, I know, and pays me plenty of tribute on that score; I know that his present sobriety and constant character development and improvement are the best tribute I could desire. Nonetheless, I must admit to a void in my own little inner world now that it has been stripped of that tendency to feel that "maybe things have gone badly for Jim and me; nevertheless I haven't thrown in the sponge! I've been a loyal wife!" Now as I look at myself, I realize how much comfort I did take from that vain-glorious feeling in self contemplation. Certainly his drinking and its attendant demands on me were sometimes pretty harrowing; just the same, I still felt pretty noble, I'm afraid.

As I look back over Jim's first few months in A.A., I can see, too, how that attitude of mine carried over and created a few minor crises that shook my faith in A.A. I blew up in completely alcoholic fashion myself over things so infinitesimal I never would have noticed them in the old days when I was wrestling with job, rent, and children problems. And I see now that it was because I hadn't worked much on my own habit-thinking pattern. Emotionally, I missed the build-up I got all the years of his drinking, when I had those big things to contend with. Being shorn of the responsibilities, and the attendant self-approbation we have enjoyed for

a long time, is hard on our mental constitution. I feel now though that it is the first thing an A.A. wife must accomplish to help get life back into normal proportions. In our own way, we too have been pretty self-centered.

Made a searching and fearless moral inventory of ourselves

first came into the rooms of Alcoholics Anonymous in September 2016. It quickly became apparent to me that people fell into two camps when it came to Step Four. Either you hated it or you loved it. But one thing was clear, and that was that it had to be done thoroughly. I was left wondering how it was going to go when it came time for me to do my own fourth step.

When it came time for me to do my own fourth step, I was still feeling pretty raw from the near constant incomprehensible demoralization I had subjected myself to for the previous two years. However, when I put pen to paper and started listing out who I harmed, how I harmed them, and it became clear to me that the reason I had acted so selfishly and recklessly wasn't because of alcohol at all. It was because I was scared. I was scared of everything. Scared of getting fired, scared of getting left by my significant other, scared of getting in trouble with the law, scared of anything that would leave me feeling abandoned, vulnerable or insecure.

Surprisingly, it felt refreshing to actually write down my part in the harms that I had caused other people. I had spent so many years lying, manipulating, doing anything I could to blame other people or set someone else up to take the fall for me. It felt good to finally take some responsibility and accountability back and get honest with myself and those around me. To me, step four was the first step in healing and towards working to create a better me. Step four was the first time I actually made an effort to get to know myself and see on paper what feelings inside me led me to drink and in turn, harm others and myself. If I hadn't done a thorough job of working my fourth step, I would not have the sense of peace and relief that I have today. Armed with this new information and a new sense of purpose, I was able to pick up the first piece of myself and begin reconstructing a new, better life for myself and begin mending the bridges I had burned.

Tradition 4 Each group is like a spiritual entity, hopefully itself growing along spiritual

lines. I have found that groups function best when they have at least one old-timer in the group to help guide them. To reach old-timer status I don't believe that one has to be very old. The idea is that this person has not only had a spiritual awakening but has carried that awakened spirit into many endeavors and has much knowledge of the practical application of our principals. In my homegroup we are looking to people who have about ten to fifteen years sober and are in their forties.

I think it was wise of the founders to allow each group to guide itself by its own group conscious. Alcoholics do not conform well to rigid codes of conduct and I believe that any attempt to do so would be snuffing out the spirit.

I believe that God is very diverse. He has expressed his diversity throughout His creation and through each one of us. It should only make sense that there would be diversity throughout the groups.

In AA we have young people groups, book studies, speaker meetings, closed meetings, open meetings, gay meetings, ect. AA is broad, roomy, and inclusive; never forbidding. It is our aim to welcome any suffering alcoholic with open arms, and any alcoholic may attend any of these meetings.

It is my belief that any group that follows the principals of AA and invites God into their meeting, may become an effective instrument for the Power that is keeping them sober.
