# Why AA Never Gives Up on Anyone

I'll have to take a bit of a short cut and identify myself briefly as a social-drinking, Turkish-bath, take-the-pledge, call-the-doctor, general-hospital, health-farm, leave-ofabsence, job-losing, long-vacation-in-Florida will-fix-meup, sanitarium, mental-hospital alcoholic, in the order named. When A. A. was first presented to me, I felt that here at last was the answer. I couldn't get enough of it fast enough. I read the book, attended several meetings, met many of the group, and lived AA so vigorously the first two weeks got "cured"—and then got drunk.

The group picked me up and explained that in my initial elation I had become over-confident, that there was much solid groundwork to be laid, and that an entire pattern of thinking and living had to be changed. Furthermore, it might not be easy, and the time might be long before I was able to rehabilitate myself both socially and economically. The first year was tough going and I suffered five or six slips of increasing intensity, until I reached the point where I felt that for me there was no help. I about gave up, but the group did not, and in some way its faith was transmitted to me. I started in once more, attending meetings regularly, gradually making real progress; some nine or ten months before I crash-dived again into Bellevue.

This was surely the end, for it came the very week I was being called to an interview for an excellent position, doing the type of work that that I had long wanted. In some way I pulled myself together, got the job and started off again, Kaweah Lake Allen L.

only to run into trouble once more about ten months later. Then I seemed to flip back considerably. During the next six months I bounced about erratically but managed by virtue of an understanding boss to hold my job. Somehow, once more I pulled out of the maelstrom, and for the past year-and-a-half have been completely dry.

I mention this brief background to make one point. There are many in AA whose recovery is apparently immediate, who after being in A.A. only a short time find complete release from their problem. However, there are as many more who just as sincerely desire to be free of alcohol but find themselves confronted with slip after slip and increasing discouragement. They doubt their own ability to be honest with themselves and the situation looks pretty hopeless to them and others as well.

I have never heard of AA giving anyone up as an impossible case, and if the individual confronted with such a dilemma can marshal even the barest physical energy to attend the meetings regularly and to keep trying within the limits of his capabilities to follow the AA program, he will progress. The time element is relatively unimportant whether it be six months, two years or more before he achieves adequate stability—for we all realize what the alternative must be.

*Came to believe that a Power greater than* ourselves could restore us to sanity.

When I came into this program I did not believe in anything. I did not believe in love or hope, the world was out to get me. I had no self worth. I Didn't believe in life and I certainly did not believe in God. My dad took me to church when we were little and at about 10 years

old I decided I was an Atheist. God was vengeful and hypocritical, and such. And the people who believed in Him, they were worse. The horrible things they did in the name of God. It was not for me.

I hear in meetings that you don't have to believe in God. You can believe in a Higher Power or even a door knob. To me God and a higher power were the same and a door knob? That's just ridiculous. So where did that leave me, confused. I knew I had to believe in something to stay sober so I began to act as if. I would say I believe in something because I did not get myself sober and I'll call it God because everyone else does. I went to A Course In Miracles Meetings. I read meditation books every morning. I'd even talk about God or "whatever" in meetings. I knew I'd stay sober because I was doing what everyone else was. But the God part didn't feel right.

An inner battle began. One day I believed in God the next day I didn't. I got more frustrated as the months went on. I would talk about it in meetings and to my friends to try and figure it all out. One day my sponsor said something like "pick a side, make a decision and quit stressing." It was at that point I began to understand. Spiritually and religion are not the same thing. God and a Higher Power are not the same thing. I do not have to believe in God. It's okay not to. I can still follow the program and stay sober.

AA is my Higher Power, and so are the people in it. My friends are my support group. What they are doing works and if I follow them and do the right thing I'll be okay too. I know something outside of myself has been helping me throughout my recovery, and it is everyone in AA. I've also learned what I think or believe is not set in stone. I need to keep growing. I still read my meditation books every morning. Someday I might believe in God and that would be okay too. At least I believe in something.

For our group purpose, there is but one ultimate authority - a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.

Tradition Two starts with the group; spiritually united in its endeavor to carry the message and having leaders who understand what it means to be a trusted servant.

Tradition 2 The spirit of all 12 Traditions is Unity; is my group united? Purpose: What is the purpose of my group and are we meeting the goal? Selfless service: Am I taking my group hostage to my way of thinking or am I allowing other members to contribute to the welfare of the group? <u>Relationship to</u> a God of our understanding; Do I listen to my HP in my decision making for the group? Conscience: The group conscience is a spiritual exercise. Anonymity: Do we, as a group, understand anonymity?

Remember: A group is Higher Powered if it is to survive.

A homegroup member is one who is dedicated to the group and serves in many capacities. AA groups have their bleeding deacon who think the group will suffer without him or her, then there is the elder statesman who listens, and sees the wisdom of the group decisions. The elder statesman has "the quiet opinion, the sure knowledge and humble example that resolve a crisis" (12x12 p 135)

As an AA member of a homegroup, I have learned to listen despite differences of opinion. That was not always the case. I became open minded. I have also learned that other ideas presented to the group are worthwhile and good for the group. It is hard to hear a loving God when I am not being loving. Ego deflation as my sponsor put it.

There are many different 'right answers' for a group. My thinking used to be 'black and white,' no middle ground. AA has taught me to think freely. Change does not always come easy, and I find myself still resisting change when a new idea is presented to the group.

When a group faces a challenge, all sides should be heard before voting on an issue. When the subject is talked to death, then a vote is taken. People are in a hurry; AA is never in a hurry. The group conscience is the true voice of Alcoholics Anonymous.

# Meet the New Office Manager

Before becoming manager, Bob served Central Office as a Central Service Representative (CSR), President of the Board, Secretary of the Board, and Board Treasurer. Bob knew the Traditions. Bob loved Alcoholics Anonymous. He was hard working, honest and dedicated to his position as office manager. At the end of the day, if the money count was off, he took money from his pocket to make up the difference. The cash box was never short.

In December of 2019, Cheryl H. was elected to the Central Office Board. Cheryl had held positions in General Service and learned the importance of setting goals in service positions within AA. In January of 2020, Cheryl and Bob discussed the fact that Bob rarely took a vacation from the office and discussed was the possibility of Bob retiring. Someone would have to be trained to run the office if Bob took a vacation or decided to retire. Cheryl knew how to run the office from years ago but did not want the position. Bob joked just last November that he would retire if Cheryl would take the job. She declined.

For several months at the central office CSR meetings, the agenda had 'succession plan' under new business then under old business. CSRs were to tell their groups about the plan and ask if anyone was interested in training under Bob. One lady showed up at the office from Porterville: Carol Ann. She said she wanted to learn about Central Office, was a member of the fellowship and had experience in accounting and business. She worked for a tax preparation company. For many months, Carol Ann drove to Central Office and Bob trained her in all aspects of the office. Bob took a day off here and there and Carol Ann ran the office in his absence.

When Bob was hospitalized December 19th, 2021, he asked Cheryl if she would see if Carol Ann was available to work until he got better. Carol Ann said yes. Bob was relieved. He trusted Carol Ann and her judgement concerning office matters.

Bob passed January 2nd, 2022. He is missed and will always be remembered for his dedication to the fellowship of Alcoholics Anonymous. He had a fabulous sense of humor.

Carol Ann G. is the Office Manager of Tulare County Central Office of Alcoholics Anonymous. She is a member, attends meetings several times a week, has a sponsor and a service sponsor.

We could wish to be moral, we could wish to be philosophically comforted, in fact, we could will these things with all our might, but the needed power wasn't there. Our human resources, as marshalled by the will, were not sufficient; they failed utterly.

Lack of power, that was our dilemma. We had to find a power by which we could live, and it had to be a *Power greater than ourselves*. Obviously. But where and how were we to find this Power?"

#### AA Big Book Pg. 62

"So our troubles, we think, are basically of our own making. They arise out of ourselves, and the alcoholic is an extreme example of self-will run riot, though he usually doesn't think so. Above everything, we alcoholics must be rid of this selfishness. We must, or it kills us! God makes that possible. And there often seems no way of entirely getting rid of self without His aid. Many of us had moral and philosophical convictions galore, but we could not live up to them even though we would have liked to. Neither could we reduce our self-centeredness much by wishing or trying on our own power. We had to have God's help.

This is the how and why of it. First of all, we had to quit playing God. It didn't work. Next, we decided that hereafter in this drama of life, God was going to be our Director. He is the Principal; we are His agents. He is the Father, and we are His children. Most good ideas are simple, and this concept was the keystone of the new and triumphant arch through which we passed to freedom."

Minutes of last meeting: Distributed to each CSR for review. Noted that the Bridge Street meeting CSR report was omitted from minutes, although the report had been given during the meeting. Board member filling the Bridging The Gap chair (Sara S.) was corrected. Motion made to approve minutes as updated, was seconded, and approved by all. Report of last Board meeting: The meeting was short, basically adding the members elected, and deciding which positions everyone would fill. We had \$256.58 total gross sales in 5 transactions for credit and debit cards last month. Traffic and calls have been about average. Carol Ann G., Office Manager. The December Income & Expense statement was presented, for November 21st through December 20th (our financial accounting period). There was a question about the website expense being larger than normal for December; Cheryl will ask Carol Ann to research.

Also, there was a web site redesign to get Announcements on the front page for mobile phone visitors.

#### H & I report: Boo reported:

Hospitals & Institutions (H & I) continue to serve the following facilities: Pine Manor Recovery, Women's Recovery Home, Mental Health, and Turning Point. Pine Manor are meeting ad-hoc, depending on Covid infection status. Women's Recovery and Turning Point meetings continue in person. Mental Health is not meeting, being a part of County of Tulare; also our local jails remain closed to meetings. H & I provides literature to facilities upon request and/or at time of in-person meetings. H & I continue to have new volunteers join our monthly orientation. We are in the process of planning a Regional H & I Workshop for early next year in conjunction with the other Areas. This will be a great opportunity to learn about this type of service work.

The committee reviewed NorCal's proposal for restructuring the committee. The proposal includes adding Area Chairs to the Steering Committee, having the Steering Committee meet 4 times a year via Zoom and holding one General Committee Meeting, which will be a two-day event. After review, our Area and Region support this proposal as it will create a democratic voting structure and will promote attendance due to the accessibility of Zoom. The NorCal Committee will begin the voting process on this proposal in January 2022.

H & I continues to encourage all groups to elect an H & I Representative and to attend the business meeting. the designated Office Manager with the bank; after the bank change, we can proceed with Venmo. Budget:

Each CSR was polled if they asked their groups if there was an interest in creating a budget. Seven groups were asked; five were in favor, one against, one group undecided.

Clayton report (reading Joyce' email, as she was unable to attend): Due to feed back regarding the recent request made to have Central Office create a budget, it has become apparent that the that intention of the request has been misinterpreted either due to presentation or perception. As a member of the local A.A. fellowship and a member of the group who made the request, I felt compelled to reach out with the following information for consideration by the Board of the Central Office. The request was made as a way to create unity through participation of the local fellowship with Central Office. The request was never meant to question Central Office nor micro manage. Alcoholics Anonymous has years of experience which can be replicated. If we look to other entities from GSO, CNIA Area 07, many districts, Central Offices, InterGroups, and NorCal H&I, we find that each create a budget or spending plan on yearly basis. This process provides the fellowship the opportunity to participate and support our service boards which ensure services are available to the still suffering alcoholic. I have the privilege of serving on the NorCal H&I Finance Committee and participated in the 2022 budget preparation.

- We started with the Finance Committee, General Chair, General Co-Chair and Treasurer meeting and going through our yearly income and expenses, reviewing each line item of income and expenses, discussing where we should increase and decrease based on current conditions.

- We produced a preliminary budget, which went to the Steering Committee for review and revision.

- The revised version from the Steering Committee then went to the General Committee for the same review, revision and adoption. Our budget is not an absolute but a guideline of where we want to be to provide the service of our committee. It also provides our Treasurer a guideline for monthly reporting of where we stand. I was also blessed to be present via Zoom as Area 07 went through the same process. It was evident that they followed the same process. The request for Central Office to provide a budget for consideration and adoption was to made to allow the fellowship to not only financially support Central Office but to be invested in the service work the Central Office provides to the still suffering alcoholic. There are several ways we could initiate this process locally: The board could review the actual income and expenses and prepare a preliminary budget to present to the CSR's or we consider appointing a Finance Chair to Board along with forming a Finance Committee who with the Board could prepare a preliminary budget which would be presented to the CSR's to take back to the fellowship for input and return for review, revision and adoption. The Finance Chair could prepare a monthly report of the actual income and expenses in relation to the budget and give a true picture of where we are and where would like to be. This process only encourages participation, through informed decision making and unity.

In a quick review of the past 5 years of Central Office's financial reports as published in the newsletter, eliminating 2020 which was an anomaly due to the pandemic, the average income of the Central Office is rounded to \$47,000 while expenses are rounded to \$45,000. Currently our bank account has increased 27% from 2017 while our expenses have remained relatively the same. This is evidence that the fellowship is willing to support the endeavors of the Central Office and since we now have more than a safe prudent reserve which by review seems \$15,000.00. It appears that it would be safe to increase our expenses to grow our unity and service work.

A suggestion could be to include some travel expenses for Board Members which are currently holding the position of Bridging The Gap and PI/CPC position to attend the conferences for each committee yearly. The experience of learning the true aspects of these vital General Service Committees from others in the same type of service, returning to implement them locally will only bring unity and service for us all while ensuring the still suffering alcoholic will always have services available. This is just one idea, I believe if we open this for discussion with the fellowship as a whole, we only stand to grow together.

I am hopeful, this provides insight into the motivation behind the request. I will be out of town on Tuesday or would have brought this information to the CSR meeting in person.

"But I got the wrong answer," he protests.


"Yeah, we know. But you were closest."
