

# Better to Be Drunk Than Merely Sober

"If coming into A.A. meant nothing more to me than being sober, I'd get out of it, get drunk and stay drunk!" said H.D., a tall personable gent, as his opening blast at a regular meeting of the Orange (New Jersey) group.

"What I mean is," explained H.D., "if I continued to think and act and live the way I used to in my drinking days, I'd be so unhappy and miserable I'd simply have to drink."

H.D. was expressing his own opinion but it turned out that it was actually the keynote of this particular A.A. group. Starting out with seven members a little over a year ago, they now number around 60 and have made quite a name for themselves. They aren't very interested in the drinking histories of the new recruits and you don't hear the blow-by-blow accounts of drunks, even in their open meetings. "All us alcoholics sound alike—why listen to a lot of chatter about binges?" they say.

As a result their meetings are very alive and not at all repetitious—everyone tells what's happened since he got into A.A. "It's a cinch nobody would be fooling around here if he hadn't had trouble with liquor. We want to hear what people've done since they got 'dried up', not before."

This bunch subscribes unanimously to the belief that they were pretty unhappy people or they wouldn't have become alcoholics; they felt the irresistible compulsion to drink to escape from life. They feel that if they merely get "dry" and

still remain in the old rut of thinking, living and working, they'll fall flat on their faces in slip after slip.

"If some guy is sitting around feeling awful and fighting off taking a drink—he might just as well go out and get himself stinking. On the other hand, if he's stepping right along into his new world he'll be too excitedly happy as new vistas of what his life can be, open up before him. It's as different as looking at the world from the bottom of well or from the top of a mountain."

One of the most interesting things about H.D. and his gang was the conversation after the formal part of the meeting. There was very little of the typical A.A. talk which is so often heard in most groups. Everybody was bursting with the things that had happened since the last time they were together—the new job, the new home, the different books they'd read, civic affairs, and what was the basic reason behind the drinking in the case of some newly contacted prospects.

It struck the writer that here was a crowd of A.A.s who were really concerned with the next 24 hours—not the last 24 years, weeks, days, hours—yes, minutes.

On some very important level, Step 6 is an extension of Step 3. After turning over our lives to the force for good within us, which is what God is to me, we now stand on the threshold of

By the time we reach Step 6, we've already made the first change: recognizing our addiction, setting our bottles and cans aside, then beginning the process of staying free of it. There is an implication, however, that to remain free we must begin weaning ourselves off of some of the other complications of being human. Being ready for that is bigger than it sounds.

Back in the beginning of my sobriety, I used to joke that if God actually removed all of my character defects, I wouldn't have any character left. With 20/20 hindsight, I can see the truth of the fear in that, because some of my biggest hindrances to living free in the Light, with the Light, are the parts of my personality that seem critically important to my existence in this world.

For example, one treasure is my ability to judge. I'm a writer, a social critic, a researcher on industrial agriculture's negative impacts on human communities. I'm an advocate for more even distribution of wealth and a healthy balance between humans and their environment. Judging is a central part of what I do. But there are days when that judging ability turns against itself and renders me useless. On those days, judging has overridden mercy and goodness and love, some of the other character qualities I want to practice. Am I ready to have God remove this tendency to judge? Or should I ask for strength in those other qualities? Do I ask for wisdom to know the difference, when to judge or not – or beg God to do the dirty work I've taken on?

It's a two-step dance: remembering that I've turned my life over (step 3) and being willing to do whatever that means, including loosening my grip on my favorite defects (step 6). It's a process, not a project. Sometimes I step on my partner's toes, but with each twirl around the dancefloor, I get better at following.

We have emphasized willingness as being indispensable. Are we now ready to let God remove from us all the things which we have admitted are objectionable? Can He now take them all - every one? If we still cling to something we will not let go, we ask God to help us be willing.

### Comments

Steps 6 and 7 are prayer requests to the God of our understanding for the transformation of our hearts. Willingness and Humility are the essential components here. My Sponsor strongly suggested that I read and study Step 6 and Step 7 out of the Twelve Steps and Twelve Traditions Book. During my first year of recovery my Faith was not very strong. I still had resentments toward "God", but my Sponsor explained to me that these Steps are the corner stones of the 12 Step arch which I will pass through as a free man. Free from relaying on myself, Free from my secrets, Free from my excuses to use and abuse alcohol, Free to have all my burdens lifted and given to my Creator. I trusted my Sponsor and he reminded me that when we first sat together in the beginning, that I would go to any lengths for victory over alcohol. Page 76 is in the first few pages of Chapter 6 "Into Action" in our Big Book. "Faith without works is dead." My Faith continued to grow as I looked at Steps 8 and 9 with the help and guidance of my Sponsor Bill M. Today I pray daily and am comfortable in my Faith.

New business: 1) Consider transportation reimbursement for office manager to attend events away from office. Tabled until next month. 2) The Porterville Iris Festival. We're going to have a Public Information (P.I.) booth at the Iris Festival but the Iris Festival has been delayed to mid- or late summer (actually, it's going to be in September). Meeting adjourned at 8:43 PM.

Treasurer and office report: Presented by Carol Ann Gable, Office Manager & Treasurer.

Central Office had an income of \$4,758.65 and expenses of \$4,658.65 for a gain of \$100.

Our Grateful Givers Club brought in \$260 and our Birthday Club brought in \$67 in much appreciated contributions.

We had \$958.66 in gross sales using the credit card and debit card transaction program Square.

Traffic and calls have been average.

We want to thank all the groups and individuals who are contributing to show their support for Central Office. Office operations are going well and we are still fulfilling our primary purpose of carrying the A.A. message of recovery.

Carol Ann Gable Office Manager/Treasurer

Cheryl H. presented information about the Monthly Income and Expense Statement (we have a new CSR present): For the month we had an income of \$4,758. Year To Date that income was \$19,275. For expenses, the total for the month was \$4,658. Total expenses for the year were \$18,936. So far we're in the black for the month by \$100. We're in the black for the year by \$339. You can see the Beginning Total Account Balance of \$20,168.71 with Ending Total Account Balance of \$20,268.71.

The Prudent Reserve set about 15 years ago is \$19 Thousand. I had a phone conversation with Joyce and I let her know about that. She still feels that the prudent reserve needs to be raised to \$22 Thousand and that will be on the Board's minutes for discussion. Her reasoning is that operation of the Central Office of six months runs around \$22 Thousand. The account balance over \$20 Thousand brought us up to our prudent reserve, so we are in good shape. If we raise it to \$22 Thousand, then that just gives us something to shoot for.

Are there any questions about the income and expense statement? Trudy asked a question, but it stemmed from having only one of the two papers of the Income and Expense Report. Second printout supplied.

Central Office will be closed Monday, May 30th in observance of Memorial Day.

We meet Sunday mornings at 10:00 AM in Blain Park in Visalia (on Court Street between Whitendale and Caldwell) (note that there is a Blain Park in Tulare, but we are not there). Our meeting is 90 minutes in a beautiful outdoor setting. This is an open meeting, and all are welcome. You do want to bring a lawn chair or camp chair with you, and perhaps a blanket. As an outdoor meeting, we are petfriendly. We celebrate sobriety milestones and birthdays every meeting. We use the Daily Reflections book as a topic starter; then everyone shares, going around the circle (time permitting). Our Secretary is Scott L. This meeting has a summer schedule (meeting starts at 9:00 AM) and a winter schedule (meeting starts at 10:00 AM). We are currently on the winter schedule.

Crossroads Group, Steve P., CSR.

We meet Thursdays from 7:00 PM to 8:00 PM, and are an open meeting. We are a group of about 6 to 14 people; we are located at 220 W. Tulare Avenue, in Tulare. We have been back at the Hillman House for approximately two months, after being dark for two years. We think we will be able to make contributions to the service entities in a few months.

Bridge Street Drunks, Sara S., CSR.

We are a large group which hosts 19 meetings, in Visalia. Our birthday meetings are the last Saturday of the month at the noon meeting - we give chips and hugs, goodies, cake and coffee. We have literature and books at cost. Our business meetings are held the last Saturday of the month at either 8:00 AM (odd-number months) or 1:00 PM (evennumbered months). We provide coffee at all meetings. We encourage anyone to join us. Our meeting schedule is: Monday through Sunday 7 AM to 8 AM Monday through Sunday 12 noon to 1 PM Tuesday evening 6 to 7 PM (literature study) Wednesday evening 6 to 7 PM (12 x 12 book study) Thursday evening 7 to 8:30 PM (Big Book study) Saturday evening 7 to 8 PM (open meeting) Sunday evening 5:30 to 6:30 PM (10th step study) We discussed opening up a Monday evening Women's meeting; previously there was one at Bridge Street. At the moment, all meetings are outside due to flooding; construction is in progress to provide new flooring. Our landlord has raised our rent from \$550 per month to \$875 per month.

Tuesday Women's Amity Group - Online, Boo, CSR. We meet every Tuesday from 6:30 to 7:30 PM on Zoom, followed by ten minutes of fellowship. The Zoom meeting ID is on the A.A. Tulare County org website. We are a Closed Women's meeting (which means this meeting is for A.A. members only, or for those who have a drinking problem and "have a desire to stop drinking"). The secretary asks someone to read the daily reflections, and/ or talk about the reading, then we share our experience, strength, and hope with each other. Our group hands out chips for lengths of sobriety to let others know the program works. Our group consists of 8 - 12 women weekly. Our group has an active phone list for newcomers. Newcomers are encouraged and welcome to attend. We are virtually signing attendance cards. Our group celebrates birthdays at the end of the month with party hats (since we can't eat together). Our business meetings are held on the third Tuesday.

#### Old business:

Shervl

1. Adding the Venmo / Paypal / credit card surcharge to purchases – discussed. Sunday PM Valley Group Serenity Seekers (Erica CSR) took a vote, and does not want Central Office to automatically add a surcharge. Civic Center Group (Brett CSR) also does not want automatic

surcharges. Bridge Street (Sara CSR) had a mixed response; some were in favor of it, others said if you don't want to pay the surcharge then use cash. Mike had the question of how much will the surcharges be? We will have to get exact numbers, but costs on \$20 are that Paypal is 5.3%, Square is 3.9%, and Venmo is 2.4%. Venmo does cost more because it requires a cell phone, which costs us \$19 monthly. If Venmo does not pay for itself in six months, we will drop it. We ask all CSRs to ask their group if they want Central Office to eat or pass on the surcharges. Crossroads Group took a vote and were in favor of automatically adding the surcharge. We will have the Venmo plaque at the Founders Day Picnic, which may be where people use Venmo.

- 2. Founders Day Picnic Sara reports:
- Our next planning meeting is (was) May 11, 1. Wednesday, at 7:00 PM, and we are online with Zoom for people in Porterville or at home who don't want to travel to Bridge Street. The planning meeting after that will be Wednesday June 1st. Central Office does have a volleyball net and ball (although the ball will need to be inflated). A member suggested we give a gift to our speaker; however tradition was been that we don't do gifts to local members. We would like to have an Al-Anon booth at the picnic. We will have a horseshoe tournament. We will have cornhole. How to get a card for expenses? Come in to Central Office and Carol Ann will give the debit card and code to Sara. Lastly, would every CSR please ask their group to make a basket for the basket raffle? One group decided that instead of making a basket, they would like to donate money.
- 2. Answering machine when Carol Ann leaves the office at 1:00 PM, the answering machine picks up, and it has Cheryl's telephone number listed. What has apparently happened is that A.A. World Services has been directing people to Cheryl's phone. International calls and nationwide calls have been going to Cheryl; Cheryl asks how they got her number, and they say they were were given the number by A.A. World Services.

New business:

- 1. Sign-Up Genius:
- 1. Member anonymity: there are two ways to protect anonymity. 1) the person creating the sign-up can make all sign-ups invisible, so that no-one can see who signed up. 2) Members can sign up with only the first initial of their last name.
- 2. Sign-Up Genius does cost money; do we want to do that?
- 3. What does Sign-Up Genius do? Examples:
- 1. Suppose you want to co-ordinate people to be on a Twelve Step Call List. You could create an event with volunteer slots for days of the week per city. People who want to volunteer would sign up for the slot that works best for them. The volunteer could get an email or visit a web site with a link; either would launch Sign-Up Genius as a web page or as an app. The event organizer gets notified of the volunteer sign-up and approves (or not). If the volunteer gives us their phone number during sign-up, Sign-Up Genius will send them a text reminding them of

their commitment prior to the time slot going live. If the volunteer does not give us their phone number, Sign-Up Genius will send them an email.

- 2. Founders Day Picnic raffle baskets: a person from each group could register that their group is bringing a basket, and what the theme of the basket is. This could help avoid duplicate themed baskets.
- 3. Potluck meals: the event organizer creates slots for salads, drinks, main courses, side dishes, deserts; people fill in what they want to bring, and can see who is bringing what.
- 4. Golf tournament, New Years party, Take Your Sponsor to Breakfast, Iris Festival, etc.
- 4. A question was about prices (researched and reported here):
- 1. \$12 per month pay-as-you-go or \$9 per month for a full year paid in advance, which is \$108. This gets two administrators, 150 texts per month, 5,000 emails per month, and 3 advertising-free sign-ups.
- 2. \$30 per month pay-as-you-go or \$22.50 per month for a full year paid in advance, which is \$270. This gets eleven administrators, 500 texts per month, 10,000 emails per month, and 10 advertising-free sign-ups.
- 3. \$60 per month pay-as-you-go or \$45 per month for a full year paid in advance, which is \$540. This gets 21 administrators, 1,500 texts per month, 20,000 emails per month, and unlimited advertising-free sign-ups.
- 4. \$1,300 for a full year paid in advance: SignUpGenius brand removal (which would be in alignment with our Sixth Tradition) and unlimited advertising-free sign-ups.
- 5. The concern was raised that the service does do advertising (which implies affiliation) at all levels except the most expensive. This is a significant drawback.
- 6. Item closed. If a situation arises some time in the future where it might be useful, we can look at it again.
- 2. Office coverage for when Carol Ann goes on vacation: Carol Ann does get two weeks of vacation every year, and has family out of town she visits. What will we do for coverage when she is gone? CSRs are asked to find members with computer skills and who could commit for an entire week at a time (person would get paid the same as Carol Ann). One member at the CSR meeting did volunteer.

Announcements: Our sister fellowship is having a Blues Festival May 21st – see a member of N.A. to buy tickets.




