A Father Looks Through His Son's Eyes

If we non-alcoholics, who have seen this alcoholic disease take possession of one who is dear to us, could change places with the alcoholic and through his eyes get his outlook on life, I believe we would be appalled.

If we could feel ourselves slipping away from everything that to us seems worthwhile—if we had become dishonest—if we had come to lying and cheating and stealing; if, as from afar through the haze, we could see our lives disintegrating, although those nearest and dearest to us tried to plead and reason, tried to save us—and steadily, unrelentingly, the mist thickened into fog, and through the fog we watched other people going about their daily routine, doing their jobs with disgusting regularity, while in the distance our homes and our families moved away, away, continually away until they were gone, completely gone; if we could know the all-aloneness of the alcoholic then, I think we might begin to

understand how sick, mentally and physically he is.

It goes without saying that we non-alcoholics want to be of help, but always our attempts seem to end up with the alcoholic drunk, for he, alarmed by his own behavior, has surrounded himself with a wall of self-justification behind which he takes refuge, and every effort we make to be of help is, in his eyes, simply an assault upon his only defense, is it any wonder then that we fail to get his cooperation, when to cooperate would be to help us tear down that defense? Is it any wonder he gets drunk?

There is one thing we can do, however, and that is to avail ourselves of the same help we ask him to accept from the Power greater than himself. We can, by the acceptance of that help, bring to order all those disturbing influences which have brought discord into our

own lives. I say that fully realizing that we can never find peace and happiness until our particular alcoholic finds sobriety.

Step 12 *Having had a spiritual experience as the result of these steps, we tried to carry this message to alcoholics, and to practice these principals in all our affairs.*

The 12th step is loaded with promise. I first learn that by thoroughly completing the steps I would have a Spiritual Experience! This psychic change allowed me grow towards my real purpose. Being of maximum service to God and the people around me.

To this end I was tasked with carrying the message of Alcoholics Anonymous. That is the message of hope. I realized that I was uniquely qualified to help alcoholics in a way no doctor, minister, social worker of family member could. When I began share my experience, strength and hope I demonstrated that the 12 steps worked. As I tried to help the still suffering alcoholic I was amazed at the feeling of usefulness.

The principals behind the 12 steps became even more important to me when remembered that feeling of sadness discussing my character defects with my sponsor. As I humbly asked God to remove those defects, my sponsor told me to practice the "opposite". He explained that I had first practiced these principals as I completed the 12 steps. Honesty, Hope, Faith, Courage, Integrity, Willingness, Humility, Brotherly Love, Justice, Perseverance, Spirituality and Service.

Now that I had seen the principals in action, step 12 encouraged me to practice them in all areas of my life. I soon learned that it was very easy when I was surrounded by my AA family, and quite a different story when I was alone in the world. I began to understand that I desperately needed help to stay on track. That help came from seeking to improve my conscious contact with my Higher Power.

As I surrendered my will, the 12 steps and their

principals began to improve my usefulness to God. The Big Book tells me "Our next function is to grow in understanding and effectiveness. This is not an overnight matter". This takes practice and more practice. I relied on my character defects (defenses) for many years and have a lot of unlearning to do. The 12 steps and their principals help me to grow spiritually and emotionally becoming a more whole healthy and useful member of AA and society.

Tradition 12 *Anonymity is the spiritual foundation of all our traditions, ever reminding us to place principles before personalities.*

The beautiful thing about writing is that it helps you learn what you think. Not even five minutes after I agreed to write about this last, and somehow most important, tradition, evidence of its meaning began to show up.

Principles before Personalities: a key phrase. We say it together at the end of each reading because it is where the rubber meets the road in the practice of our faith. We had to practice it hard recently at one meeting I attend because there were still track marks from burning rubber years ago in a couple of people who hadn't seen each other in a while. I would like to say that we alcoholics, of course, have personality defects that make us hard to live with. But then I go out into the world of normal people and find that they do, too. **Principles before personalities** – it's the ultimate meaning of the Christian faith as well as ours: to love one another. Tolerate. Accept. To set one's self aside so that the other's true self can emerge.

Anonymity. We say the word so often – once we learn to pronounce it, or even mispronounce it (and some people never get their tongues wrapped around its slippery 5 syllables) – its meaning gets lost. But the true meaning is critical in the practice of our faith. Anonymity is not just having one's identity protected. It is letting go of the position in the world (high or low) that one's name provides. It is even letting go of the position in our AA communities that we feel we earn over the years. For instance, at the same meeting I mentioned above, where tires were screeching as

I walked in, I found myself feeling insulted by a newcomer who welcomed me as if were a newcomer, too. I was instantly affronted that it wasn't clear that I belonged there, that I am at least the princess of that meeting if not the queen – or, at the very least, now a principal member of that meeting. Once I realized that my anonymity was missing in my own mind, it got much easier to participate in the healing sharing that needed to occur – for all of us.

Spiritual foundation. With the gritty details of alcoholism always in front of us, it's easy to lose sight of the fact that we are here, together, because of some kind of holy mystery. I often feel lucky to have succumbed to wine, because I doubt that I would have found my way to the spiritual basis of this "simple program" without it. Many of us have tried church and not found it there, in part because religion, at least in America, confers a step up in status, or reflects some kind of personal accomplishment, the opposite of anonymity. Amongst church people I have often felt myself feeling less than worthy amidst all those "successful" people, reinforcing my shame instead of being relieved of it. I want to say it's not their fault. I was there for the same reason: to improve my identity. Until I was ready to swap status for self-esteem, and live the way my heart truly believes, in sync with the rest of the world, no mystery could descend on my head.

Ever reminding. Our personalities, and our social identities, are important for getting through this life, so I don't think we should chastise ourselves too harshly when they take over. They're like what husbands and wives say about each other: "can't live with 'em, can't live without 'em." But when we're together in meetings we need to let them go. Some people with decades of sobriety confess beautifully that they still need meetings, and I think it's because our gatherings are one of the few places we can count on to be safe without putting on our armor of status. Meetings are where we (should be able to) rely on the principle of belonging even when our personalities rub people the wrong way. To be able to sit there in our full humanity, equal even if imperfect.

When we practice this tradition, we are blessed and a blessing.

Meetings Online Anytime

Sobriety in Alcoholics Anonymous embraces as its fundamental principles total abstinence of recreational intoxication and the pursuit of vital spiritual experience. Practicing the twelve steps and meeting with our peers on a regular basis will allow most newcomers relief of the obsession to drink. Failure to reach this first step milestone is almost always coupled with resistance and stubbornness and a failure to “follow our path” like the Book says.

Spiritual connection is another goal entirely. Where obsession to drink is often relieved simply by not drinking, surrender and connection to a higher power seems like muscular body conditioning. There is no holding area where we can relax our pursuit of progress and we can easily slip back into lethargy. We can't build an impenetrable wall between our serenity and our character defects. I was baffled when it was explained to me, early in sobriety, that these defects of character plague us as long as we resist them. It's an enigma, you hear it all the time. We must surrender to win. Powerlessness over hate, lust, financial imprudence, and jealousy are just a few examples the defects that persist into long term sobriety.

It would appear that we could use our own control, our own energy to avoid these pitfalls, but in practice it seems not so. Only a spiritual channel to dispose of these rotten spots in our personalities is worth the effort. It's why, long after we turn over and become grateful for and used to abstinence from anything alcohol we are unable to avoid an occasional lapse into spiritual aridity and find ourselves in the grasp of old ideas and reactions.

Gratefully AA provides an ocean of opportunities for us to recover from these low spots in our daily living. Our Big Book never fails to provide insight and a patch for spiritual slow leaks. Meetings warm our coldness and misplaced individuality. Service to others rescues us, puts us in touch with ever illusive humility and there is a wealth of writing available and, certainly not the least, prayer and the practice of meditation afford us a rest stop, when life has us in life's fast lane for too long. The towering twelfth step calls this necessary should we effectively carry

the message.

All of this is why a daily experience including these rescue methods are irreplaceable if our personal lives, our struggles, are to be aligned in serenity. If we only experienced good times, the emphasis on spiritual connection might be of less importance. That is seldom our story. We will have to be in the aura of protection that our spiritual health provides.

Hospitals & Institutions December 2022

Thank you for your continued support to the Pink Can, which allows us to continue to carry the message of Alcoholics Anonymous to Alcoholics in Institutions and Treatment Facilities. Please encourage all groups to send in their pink can money prior to December 31, 2022 for the fiscal year end.

At our December 3rd, 2022 Area H&I Business Meeting, Boo M. stepped down as Area Chair after two years of service. We are very grateful to Boo for her service keeping H&I active during the Covid period. In the interim, Joyce R., Regional Chair, will handle the Area Chair duties. Jared C. was elected as the Area Secretary. Due to a conflict with the NorCal Area meetings, our Area H&I Orientation and Business meetings will be held on the 2nd Saturday of odd months at 526 N. Bridge St., Visalia (Bridge Street Drunks Only). The orientation will begin at 9:00 am followed by the business meeting at 10:00 am.

We are very inspired that SATF at Corcoran State Prison has reopened to H&I Panels in December along with Tulare County Jail which we hope will have its first panel in December. Both of these Facilities have been closed since 2020 due to Covid. Tulare County Jail has two women cleared, three in the process, two men beginning the clearance process to complete our allotted team of 7. As we move into the new year, we are hopeful that we will add 2 Spanish Speaking volunteers for Tulare County Jail also. We will continue our H&I meetings at Mothering Heights Women's Recovery, Turning Point and Pine Recovery. We will also be looking to expand our scope of service to include more treatment facilities and facilities serving homeless to move more in alignment with the AA Treatment Committee.

On the Regional level, Area 92, Fresno County continues to bring meeting to several facilities including Spanish Speaking meetings. They have begun working with a facility which services transitional homeless individuals and have two other facilities they are working with to expand their service. Area 91, Madera/Mariposa is very active in the Chowchilla Prisons both English and Spanish and Mariposa has returned to the Mariposa County Jail and Mt. Bullion Fire Camp.

At the NorCal level, we are approaching our normal 33,000 meetings per year. The IVSS (Inside Visiting Sponsorship Service) Program is providing one on one outside sponsorship to 86 inmates at San Quentin; 5 at Salinas Valley. We have a new coordinator at Soledad to begin the program there. This program has now been implemented in Tucson, Arizona which is evidence that the program is transferrable. The AA Corrections Desk has committed to having printed material available regarding this program available by year end making the program nationally available. The next orientation and business meeting will be January 14, 2022. Orientation at 9:00 am, Business Meeting at 10:00 am at 526 N. Bridge St., Visalia. Please join us if you are interested in this type of service work.

Old Business: Employee Retention Credit (ERC). This office had a loss of around \$6,000. The board talked about it, and did want the office to apply for the credit. There was much discussion. Bill made a motion to hire a representative to do the paperwork for the I. R. S. Refund under the Employee Retention Credit with expenses not to be more than 15% of the refund amount. Patrick seconded the motion. Votes were taken, four board members voted yes, one board member voted no. The motion passed. The meeting adjourned at 9:00 PM.

Treasurer and Office report: Presented by Carol Ann Gable, Office Manager & Treasurer.

Treasurer / Office Report and Financial Report November 8th 2022 Central Office had an income of \$3,642.85 and expenses of \$5,518.40 for a loss of \$1,875.55. 1 Patrick had previously given us notice that he would be late getting to the meeting. Our Grateful Givers Club brought in \$245.00 and our Birthday Club brought in \$47.00 in much appreciated contributions. We had \$671.27 in gross sales in 8 transactions for credit and debit cards last month.

We had 1 transaction in PayPal for \$20.00 We had \$279.50 in gross sales in 4 VENMO transactions this accounting

period.

Traffic and calls have been average.

We want to thank all the groups and individuals who contributed to show their support for Central Office.

Office operations are going well and we are still fulfilling our primary purpose of carrying the AA message of recovery.
