Introductions: Past delegates and board members all introduced themselves including new members, and members celebrating milestones.

Concept of Month: read by Vicki, she also stated delegates were created by the areas back in 1951 in Cleveland Ohio at the first conference. There were 93 delegates from the U.S. and Canada.

Assembly Reports:

Winter Assembly is being hosted by District 57 in Gridley Ca January 21-22. Members attending should book their rooms early as there are not too many in Gridley. Some may need to stay in Yuba City and travel. Encouraged GSR from Districts to attend the assembly.

Pre-Conference Assembly_District 37 has secured a location in Tracy California and the Tracy Community Center. District 37 has paid the deposit for the location and the district has created a committee to organize the event. They have appointed a chair for the committee (jeff) who is working on finalizing the event flier and will be available in January at the Winter Assembly.

Post-Conference Assembly District 15 is working on securing hotels but they have a location and date set.

Election Assembly District 22 will host the election assembly in November 2023 at the American Legion Hall 4561 Greenstone Rd. Placerville CA.

Liaison Reports:

H&I: Vicki stated they are holding steering committee meetings quarterly with area chairs from H&I. They are always trying to improve communication to members and people incarcerated. Currently looking for more H&I volunteers for the institutions across the state.

Central Office & Intergroups: Darryl stated they have a full board starting in 2023. Teleservice coordination has been filled. Financially they are doing well and

have a strong prudent reserve which they voted to put into a CD. Fresno meeting scheduled for Christmas and New Years Alcothon events.

NCCAA: No Announcement

ACYPAA: They are hosting a NYE event in Sacramento and Gina B is the main speaker. Event starts at 8pm.

Hispanic Women's Conference: No announcement

Treasurer Report: Holly stated that the spending plan was approved at Mini-PRAASA and there has been concerns from groups regarding the translation budget. The finance committee has amended funds in the spending plan from line item 165 (\$11,260.00). Breakdown

- 1) Translation at Area Assemblies up to \$5,500/ year (\$585 for professional translator x4; \$195 for special worker x5; plus, lodging and mileage)
 - a. Saturday (12pm 10pm)
 - Spanish translation provided at \$65 per hour for 9 hours (1/hour unpaid meal break)
 - ii. Additional break covered as needed by Oral Translation chair
 - iii. Lodging and milage reimbursed
 - b. Friday and Sunday portions of Assemblies (7pm-10pm; 9am-12pm)
 - i. Spanish translation provided by our Translation Chair as a special worker at \$65 hour for 3 hours
 - ii. Lodging and mileage covered under Oral Translation Chair position
- 2) Spanish Translation at Area Committee meetings \$1760/year
 - a. \$40/hour for 2/hour blocks and ^0/hour for time that exceeds 2/hours without a break (\$220 per ACM)
 - b. Mileage reimbursement under the Oral Translation Chair position
- 3) ASL Translation provided upon request up to \$4000/year (subject to increase based on need)

Finance committee felt it was important to pay for translators including assemblies. Translators are working through the entire assembly to translate everything said during the meetings.

Consideration of 2023 Calendar was approved- Claudio Chair would like to have an Area 7 70th Anniversary event in the summer of 2023.
