## Step 3

"Made a decision to turn our will and our lives over to the care of God as we understood him"

When started my AA journey I had my own beliefs and ideas of what a relationship with my higher power looked like. This step allowed me hope, that I wasn't alone, nor did I have to do it all on my own. I felt hopeless constantly resulting back to my addiction. When doing step three it gave me hope for a future, hope for recovery. That I can't but God can. Something greater than myself can help me and restore me back to sanity and give me hope for the future knowing I am no longer in control, but God is in control over my life. Just getting out of detox withdrawal's out of the hospital in ICU because of my drinking I needed someone or something so desperately to intervene in my life. Come save me from myself! I truly believe that God met me in my hospital bed and gave me the willingness to finally surrender and say, "not my will God but your will." I don't know exactly when the shift started but I am glad that God met me where I was and gave me the gift of desperation and the willingness to believe in this program and my higher power. Today, what my higher power is doing for me I am working constantly to be a better person, doing daily inventory. I am of service today to those around me, I am present and dependable today! I suit up and show up for my own recovery and give what was so freely given to me!

## Tradition 3

"The only requirement for AA membership is a desire to stop drinking."

That's what Tradition 3 says & this was my lifeline when I was new, because it kept me in AA until I heard the message: that if I wanted to recover I had to get a Big Book, get a sponsor and take the 12 Steps.

This Tradition is interesting because it's the only one of the Traditions that was in the AA literature right from the start. Tradition 3 was in the Big Book when it was first published in 1939. In the Foreword to the first edition, it says:

'The only requirement for membership is an honest desire to stop drinking.' So when they were writing the Big Book, Bill W and the other early AA's realized they had to find a way to throw AA's doors open to all alcoholics! So they kept the requirement for membership simple. They even dropped the "honest" bit, which was just as well for me as it took me a while in AA to really get honest about myself!

So why is Tradition 3 still important to me now after 2 years in AA? When someone asks a million questions about whether AA is this or that, or they just look scared, full of fear, worry, or maybe they have picked up some bad misconceptions about AA, Tradition 3 breaks through all that. We can say with absolute confidence that if they want to stop drinking, they are welcome here.

We offer friendship and fellowship. But most of all we have an Answer, a Solution.

That's good news.

But the even better news is that if you want to recover you simply need to get a Big Book, get a sponsor and take the 12 Steps of AA.

"I am responsible – when anyone, anywhere reaches out for help, I want the hand of AA always to be there, and for that: I am responsible,"

However, we won't have that tonight because Carol Ann is out sick, and when I got here, I didn't go online into the accounts before David got here and set up the computer. Prudent reserve will continue to be listed. Then we had a discussion on how to connect people to P.I./C.P.C. In announcing requests for volunteers, we asked people to contact Central Office and Carol Ann would forward them to Patrick. The meeting adjourned at 9:19 PM

January 20 – the group contributions were \$2,788.62. I was floored at that and I really appreciate the groups contributing to Central Office. The Grateful Givers Club was \$405.

Under expenses, we didn't have anything major. We had to pay our quarterly taxes, which I do appreciate Carol Ann being on top of that. Thank you for your continued support to the Pink Can. On January 28, 2023, NorCal held its first Committee Meeting utilizing our adopted restructure. It was well attended and many of the 44 Areas were represented by their Area Chairs. We utilized our newly updated meeting format which includes a time of collaboration on issues that Areas face. While the restructure has opened communication in our committee, communication with our fellowship which funds our activities remains dependent upon AA groups electing a Group Representative. We encourage Group Representatives to attend our Area Business Meetings as voting members relaying their groups conscience. This allows our Area to bring the collective conscience of Tulare County to the NorCal Committee Meetings as we are represented by our Area and Regional Chairs.

At the Region level, we find Fresno active and expanding their H&I service commitments.

Madera remains active in the Chowchilla Facilities and Mariposa has once again began taking

H&I panels into Mariposa County Jail and the Fire Camps.

At our last Tulare County Area Meeting, we welcomed Violet Q. as our Recording Secretary. We have welcomed 6 new volunteers, and spent the last month contacting our current volunteers to ensure that all are participating at the level they desire. Since our last Area Meeting, we have had a change in two of our Facilities as the Coordinators have stepped down from their positions. We are in the process of orientating new volunteers for these positions, while our H&I panels continue twice a month at Turning Point, Pine Recovery, and Mothering Heights Women's Recovery. Once a month we take panels to the Mental Health Transitional Living Facility. H&I Panels are continuing at Tulare County Jail, Corcoran and Avenal Prisons.

Our next meeting is on March 11, 2023 at 10:00 am. Orientation will be held at 9:00 am on the same date at 526 N. Bridge Street, Visalia, CA. If you are interested in this type of service work, please join us.

The Post-Conference Assembly team has secured a location in Chico California. That's May 6 and 7. The Finance Committee is recommending that CNIA increase its prudent reserve from \$8,000 to \$14,000. Jenn D. our Delegate to New York presented a lot of stuff. There are 180 agenda items at the conference which are going to be discussed. There were over 1,400 stories submitted for the 5th Edition of the Big Book. If your groups have ideas on the type of stories that should be included out of those 1,400 you should send your GSR to inform the delegate at the Pre-Conference Assembly in April which is going to be in Tracy California. The registration form for the Pre-Conference Assembly is already on https://aa-tulareco.org . Look for upcoming events: CNIA 07 PreConference Assembly 2023. Registration is \$12. If you want to sign up for dinner, that's another \$15 to \$16.50 depending on whether you're doing vegetarian or not. Hotel rates were \$140 to about \$170. It's just the one night. Your GSRs, if they want to go, should get the forms now: print them out, write a check and mail them. There is no online registration for the PreConference Assembly.

Jenn did bring up on Saturday at the Area Committee Meeting (we attended via Zoom) of those 180 agenda items, several of them said "we want you to change back (something)." What the conference has decided is that instead of dealing with these agenda items, piecemeal, there's going be one big agenda item that says "What do we want the policy to be with regard to updating the language when it was written by the original founders?" So, they want this overall opinion: what does AA want with regard to what Bill Wilson and Dr. Bob wrote? That's where it will be really important for a GSR to talk to the delegate and say "set it in stone, never change it" or maybe there are people who are like, "no, we've got to get with the times, we've got to be modern."

Our delegate will be here. We have an opportunity to talk with her. Our groups should get a GSR and talk amongst the group and get the group to say "this is what we want" and that GSR needs to talk to the delegate, and the GSR needs to go to the Pre-Conference Assembly which is in Tracy, California.

(Cheryl) The first weekend of March is PRAASA. It's the Pacific Region Alcoholics
Anonymous Service Assembly. This year, it's held at Marriott hotel at L.A.X. This is where people, AA members, delegates, GSRs, and DCMs converge to talk about everything. The Big Book is still on sale for \$9.83 for the hard cover. Sara is working on starting a Bridging The Gap committee; the first meeting date will be scheduled soon. (By now, it has been). The Lindsay Fireside Fellowship group is now officially dark: the church where it was held has closed. That was the last English speaking meeting left in Lindsay. There was no old business or new business; but we started talking about plans for the Founders Day picnic, the golf tournament, and (perhaps) a New Year's Eve party.

**H&I Report:** Rafael D.

Tulare County H&I continues to bring H&I Panels twice a month to Turning Point, Pine Recovery, and Mothering Heights Women's Recovery. Once a month we take panels to the Mental Health Transitions Living Facility. H&I Panels are continuing in Corcoran SATF and Avenal Prisons along with the Tulare County Jail. At our January 14, 2023 Area Meeting, we welcomed Violet Q. as our new Recording Secretary, discussed utilization of current volunteers and welcomed three new volunteers who attended orientation. Our Area Chair position remains open. We are also holding zoom orientations as needed on even months. We will be looking to expand to other facilities in the area to carry the message of Alcoholics Anonymous. At the Regional level, Fresno Area 92 continues to expand their meetings and are growing in their volunteers and leadership team. Madera/ Mariposa Area 91 remains active in the Chowchilla Prisons and Mariposa is once again active in Mariposa County Jail and Mt. Bullion Fire Camp.

At our January 28, 2023 NorCal Committee Meeting, we welcomed Area Chairs to our voting body and had a very interactive meeting sharing ideas and supporting the Areas. The IVSS Program which offers one on one sponsorship to inmates is growing. Currently, this program has 112 inmates on its roster and is in need of more volunteers as San Quentin currently has 38 inmates waiting for sponsors. This program is in the process of being added to the GSO Corrections handbooks as it has been proven to be transferrable. We will also begin on a trial basis rolling this program out to County Jails and Treatment Facilities. This will provide the opportunity to provide sponsorship to confined alcoholics in more facilities. While this program operates under the H&I umbrella, volunteers who participate as an IVSS sponsor do not participate in H&I panels at the same facility. This policy helps to avoid confusion of the purpose of the two programs. Our next in-person orientation will be

March 11, 2023 9:00 am followed by the Area Business Meeting at 10:00 am at 526 N. Bridge Street, Visalia (BSDO meeting place).

**DCM Report:** Mike C., Alternate DCM attended the Winter Assembly meeting.

Pre-Conference D37: Gavin stated they have secured location in Tracy Post-Conference D15 (Chico): The post conference will be held at Lincoln High School and online registration will be available in a few weeks. New Business: None

Finance Committee: Don H. stated the committee met and Prudent Reserve will go from 8k to 14k. The webpage has been updated and will be unveiled this weekend. (Feb 7) The new website will have a calendar on it **Announcements:** None where the ACM meetings will be added and the zoom link for attending.

**<u>Delegate Report:</u>** Jenn D. Jenn discussed the importance of the GSR and A.A.'s future: To place our common welfare first, to keep our as trusted servants of AA we need to remember that the future of AA is in our hands. GSRs and Home groups are the leadership of AA. Our job as GSRs is to take information shared at assemblies back to our home groups to get their input from Agenda Items than bring back our group's conscious to the pre-conference assembly.

There are 180 agenda items at the conference which are being discussed that will go forward, and half are related to literature.

Translation process for the Agenda Items is about 80% complete in English, Spanish, and French. The agenda items and background will be available by mid-February.

DCMs and GSR should hold an agenda item workshop and need to get a group conscience before the pre-conference assembly in April. Prepare questions for Jenn and the board and what they mean for AA. DCM when hosting a workshop, we should ask the GSR from fellowships which items they would like more clarity about. Some people may not have a computer or access to print we should

inform our groups as best we could regarding agenda items and background information.

Bring our groups conscience and speak about who was in favor and who was not, tell why they were not in favor of the agenda topic. There was not a preliminary agenda released in October this year. The agenda topic items will be as follows: "Review, Discuss, Consider" The 5th edition will be the same the only changes that will occur is the stories in the back.






