### *Step 4* "Made a searching and fearless moral inventory of ourselves."

Next, we launched out on a course of vigorous action, the first step of which is a personal housecleaning, which many of us had never attempted . AA Pg, 63 When I came to Alcoholics Anonymous it was easy to understand that that if I took even one drink, I would not be able to stop. I clearly was powerless over alcohol. The problem was how to stay stopped. At that point I became willing to turn my will and life over to a Higher Power.

My sponsor helped me understand that I needed to get down to the causes and conditions that made my life so uncomfortable. Chapter 5 explained that an inventory is a fact-finding fact-facing process to discover the truth, to identify damaged or unsalable goods that needed to be discarded without regret. This was exciting to realize that I could do the same thing with my life.

I had never done anything like this before. I heard several men share about how the 4th step inventory had helped to change their lives, this motivated me to begin. As I listed the people, institutions and principals I had resentments with I was surprised to see the trends in my problems. The first awakening happened when my sponsor and I had looked at what my part in all these resentments was. I began to understand that I only thought I was a victim I was in fact the perpetrator, the architect of my problems. In every relationship I had been selfish, self-serving or dishonest. Accepting

this was a difficult pill to swallow however, the emotional lift I felt when I shared these problems with my sponsor was incredible. The awareness that I was responsible for the vast majority of my problems was empowering. I began to feel free. The next awakening happened when we explored my fears and sexual behavior, the awareness of my responsibility grew. I saw for the first time that I had a played a major part in everything bad, wrong or uncomfortable in my life.

As I sponsor men through the 12 steps, I identify more and more of my character flaws and defects. Continuing to practicing the 4th step allows me to grow in my usefulness to God and my fellows.

Resentments happen. Today I understand that I can do a 4th step inventory whenever I have a situation that makes me feel uncomfortable. I have learned that for my personal spiritual growth resolving resentments is as important as prayer and service and more important than not drinking.

If you have any reservations or fear about taking the 4th step I have only one question for you, how free do you want to be?

Thankfully, that special trudging-inflicted humility won them over and they began to see that groups form in different crucibles. Some meetings were covertly intolerant of young people

(their chances were less than average!), Sometimes the Al anons objected to women's attendance.Sometimes all the local people were Mormon or Catholic, or Presbyterian and they wanted to conduct meetings which incorporated or reflected these beliefs. AA was not was not without differences at the group level.

Now we know it can't be! But as long as your customs do not affect other groups or AA as a whole, group conscience sets boundaries. You can, as a group, drink chicken blood, use unlimited profanity, or talk about Buddha. Group conscience is given real meaning because we are AA enough to tolerate practices that others use to stay sober.

The big boys at New York explained this to me in detail. In calm and considerate language they related that AA would survive and that each group's personalities would too. We are a strong enough organization to survive atrocities like heresy, hypocrisy, immoderation, overly religious leanings and yes, even the misplaced and unwanted Bleeding Deacon old timers.

Long live our diversity!

Office operations are going well and we are still fulfilling our primary purpose of carrying the AA message of recovery.

Tulare County Hospital and Institution Committee March, 2023

The only purpose of the Northern California Hospital and Institution Committee is to carry the message of AA to alcoholics in Corrections and Treatment facilities and facilities serving alcoholics in Northern CA.

Our committee officially formed in 1946 (predating the General Service Structure of today) to organize and coordinate the many volunteers interested in this type of service work which began behind the walls at San Quentin in 1942. The implementation of passing the Pink Can to fund our efforts began in 1957. Today, Nor Cal H&I continues to operate as a 9th tradition Service Committee funded by the Northern California AA fellowship by passing the Pink Can. We have combined the purpose of AA's General Service Corrections and Treatment Committees. We cover General Service Area 06, Area 07 and the California Portion of Area 42. While you may hear about Nor Cal H&I in different arenas, it is important to be aware that we are one Committee. If you are aware of AA members interested in this type of service work and are not familiar with your local Area Chair, please refer them to your Central Office or Intergroup to connect them with the local H&I Committee. One of our newest services is the Inside Visiting Sponsorship Service (IVSS) Program, which brings one on one sponsorship behind the walls. Currently, we have 112 inmates at San Quentin who are being served by this program with 38 more waiting. This program is being rolled out to two additional prisons in California, and has been replicated in other States to ensure that it is transferrable. This year one of the agenda items for our upcoming General Service Conference is to include this program in the General Service Corrections Handbook. We encourage all groups consider supporting this agenda item which will make this program available worldwide.

In Tulare County, we continue to take H&I Panels to Pine Recovery, Turning Point, Mental Health Transitional Living, Mothering Heights Women's Recovery, Tulare County Jail, Avenal Prison, SATF and Corcoran Prison. At our March 11, 2023 meeting, we discussed the need to reach out to other facilities. In order to do this, we really need some volunteers with a minimum of three-years of continuous sobriety to serve as Facility Coordinators. We ask that you share this need with your groups along with the need for more volunteers for Avenal, SATF and Corcoran Prisons, which requires two-years of continuous sobriety.

Our next H&I Orientation is May 13, 2023 9:00 am followed by the Business Meeting at 10. We meet in-person at 526 N Bridge St., Visalia (BSDO's meeting place). Please encourage any interested AA members to attend or have them contact myself directly through Central Office.

(Cheryl) Any questions for Joyce?

(Bill) Yes: For people that want to are interested in volunteering, how clear does their record have to be? And can you help them get it cleared?

(Joyce) For treatment facilities, we have one facility that requires that you don't be on probation or parole. They don't care what your record is. Other treatment facilities don't have that requirement. The prisons and the jails: mostly it's that you're not on probation or parole and you can't have been in the facility recently – I think it's for a year that you have to have been out. They will require a background check and disclosure of any arrests that you've had. But as long as it's disclosed it's generally not a problem. And ultimately we can work with anybody on that.


