Tradition Eleven: Navigating the Spotlight While Maintaining Anonymity

In the world of recovery, the 12 traditions of Alcoholics Anonymous (AA) are like guiding stars, helping us to preserve the primary purpose and integrity of the program. Tradition Eleven, in particular, has played a significant role in my personal journey to sobriety. It states, "Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio, and films." I'll share my experience with this tradition, a journey that has shown me the delicate balance between my personal recovery and

the greater principles of AA.

My journey in recovery has been an intimate and private one, as is often the case for many of us. The importance of maintaining anonymity at the level of press, radio, and films, as outlined in Tradition Eleven, has always been clear to me. However, my sobriety has opened doors to a new career which has often put me into the media's spotlight. I found myself featured in newspapers, on the radio, and even on television. Yet, this success came with its own set of challenges, especially when my job has been to highlight recovery resources.

In my professional role, I often discussed these resources, and on occasion, I mentioned my own journey as someone in recovery. However, my understanding of AA's principles, nurtured through meetings with my sponsor, shared experiences in AA meetings, and my study of the traditions, continually reminded me of the importance of preserving my personal anonymity.

I realized early on that disclosing my AA membership could carry both personal and program-related consequences. If I were to relapse or even just act in a way that others found unbecoming, my actions could tarnish the reputation of AA as a whole. Even more concerning, it might lead some to form opinions about AA without truly understanding the program, a concept known as "contempt prior to investigation."

Despite these challenges, I found a way to balance my desire to help others with the responsibility of safeguarding the program. When it was appropriate, I chose to publicly disclose that I was "in recovery" without mentioning AA or my specific group. This choice allowed me to connect with people who were seeking assistance, opening doors to discussions about recovery without breaching Tradition Eleven.

In one-on-one interactions, I've felt more comfortable sharing my AA affiliation, even mentioning my specific group, the Rainbow Group. This has allowed me to guide individuals through the doors of AA meetings, in accordance with AA's traditions.

Tradition Eleven serves as a reminder that attraction, not promotion, is the key to carrying the message of recovery to those who still suffer. It teaches me that my individual actions can profoundly impact how others perceive AA and, by extension, their willingness to seek help. By sharing my story responsibly and always placing the principles of AA above personal recognition, I've tried to implement Tradition Eleven in my life.



CENTRAL SERVICE MEETING MINUTES

Central Office and Central Service Representatives Meeting Report

Date: October 10, 2023

Meeting called to order: Cheryl H. Time: 7:00 PM

Board members present: Cheryl H., Bill E., Patrick A., Sara S., David G., Carol Ann G. Absent: none

Serenity Prayer: Lead by Cheryl H., said by all who wish.

12 Traditions: Cody

Minutes of last meeting: Reviewed by all. Cody moved to approve, motion seconded by Bill. Vote: all in favor, none against.

Report of August Board meeting: Meeting called to order September 12th at 9:00 PM by Bill Evans. Five of six board members were present; Cheryl had told us last month that she would be absent this month and Bill would chair the Board meeting. Vice-President's Report: Bill stated that he's not eligible to run again; his term ends in December. The minutes for the Board meeting incorrectly stated that the upcoming election would be for positions of President and Vice-President: no, the election is only for Board membership. After the election, the five board members decide among themselves who will fill which position. Cheryl gave a history of the Bridging The Gap (BTG), Public Information (PI), and Cooperation with the Professional Community (CPC) positions and which service structure they were within over the years (Central Service versus General Service). We also talked about the office being closed on bank holidays. Old business: We did sell the unused sound equipment for \$200. New business: We talked about asking the CSRs to ask their groups about putting their CSR reports in the Meeting Guide app. We discussed the increasing cost of literature from AAWS, but tabled any action to next month. We discussed the last five months of being open on the last Saturday of the month; a motion was made and passed to extend this through December. George asked how it worked out financially: expenses exceeded income by \$225, and we had had four visitors over the five Saturdays. On average (over ten months), we get three visitors a day, Monday through Friday. Page 5 of the newsletter listed the Office Contacts numbers for September. The meeting adjourned at 9:39 PM.

Treasurer and Office report: Carol Ann provided the report.

Treasurer / Office Report and Financial Report 8/21/2023 through 9/20/2023 October 10th, 2023 Good evening! In June we purchased a new Eco Printer for \$380.00. I should have included that info in the office report for that accounting period. Sorry I didn't include that info previously. Rumor has that we will be able to use 32 reams of paper with the black ink we have on hand! That will be very cost effective! We also have the ability to email right to print so, call me if you have the need to use this function.

Central Office had an income of \$3,086.10 and expenses of \$3,476.90 for a loss of \$390.80.

Our Grateful Givers Club brought in \$206.62 and no one donated to our Birthday Club! Thank you Grateful Givers for your much appreciated contributions.

We had \$437.68 in gross sales in 17 transactions for credit and debit cards, 1 transaction in PayPal for \$20.00, and \$220.00 in gross sales in 2 VENMO transactions this accounting period.

Traffic and calls have been average.

We want to thank all the groups and individuals who contributed to show their support for Central Office.

Spectrum had a phone and internet service outage on September 29th for 45 minutes from 11:00 a.m. to 11:45 a.m.

Office operations are going well and we are still fulfilling our primary purpose of carrying the AA message of recovery.

We have lots a great stuff here at the Central Office to help you share the message of recovery, come and see what's new!

The office will be open 9 to 1 the last Saturday of the month, again, this is only for the last Saturday of the month. We had 3 visitors the last Saturday in September. Two of them were the mailman; he came back a second time with a package for us.

Please announce to other members and your groups that Central Office will be open the last Saturday of the month for the remainder of the year.

(Bill): What did the postman bring? (Carol Ann): It was a package of chips. (Sheryl): Sounds like Venmo sales are great. (Carol Ann): Yes, it's wonderful. (Cheryl): When Spectrum went down, was that a surprise outage or was that planned? And did they call you? (Carol Ann): It was a surprise outage, but they did call us. (Cheryl): What's our checking account and cash balance? (Carol Ann): We have a total of \$19,978.22 and all of our payroll taxes and everything are all current. (Cheryl): For everyone's information, our prudent reserve is \$19,000 and we will be going under our prudent reserve to fund our New Year's event. We're quite confident that our New Year's party will generate enough revenue to put us back above our prudent reserve. Toward Christmas time members come in and purchase books and gift items for Christmas and that helps a lot. This is the first time in Central Office's history that we have reached our prudent reserve. We've been above it for several months. I'm quite happy with that. (Cheryl): Do we have any questions for Carol Ann? (Cody): Why is the prudent reserve \$19,000? That seems pretty high. (Cheryl): Well, it is high. But what we do is take our operating expenses for six months: salary, rent, utilities, taxes, everything. It was \$17,000 for probably 15 years and we never reached that. Last year we did some research on it and raised it to \$19,000. That gives us six months.

Public Information report: Patrick A. provided the report.

Public Information & Cooperation with the Professional Community (P.I./C.P.C.). We inform professionals and future professionals about A.A. – what we are, where we are, what we can do, and what we cannot do. We attempt to establish better communication between A.A. and professionals, to establish simple, effective ways of cooperating without affiliating.

I would like to say thank you to David and Ali for helping out the health fair that we just had. I was not able to be there and they both were there for the entire duration. I would like to hear from them a little bit about the event.

(Ali): It was truly an honor to be of service. I got a bit emotional beforehand, realizing that in my journey of sobriety, I never imagined standing up in front of people and representing something that played a pivotal role in saving my life. It was an exciting experience. Both David and I went through our pamphlets, engaging with many individuals. Some were pointing out their friends as possibly struggling with alcoholism, and they took pamphlets. Our location was fantastic, with flu shots attracting a lot of foot traffic. I highly recommend doing it again next year. David did an excellent job encouraging people, suggesting that even if A.A. didn't resonate with them, connecting with Al-Anon could be beneficial. We even sold a Big Book and distributed numerous pamphlets. Overall, it was a great event.

(Bill): Who were all of the volunteers?

(Ali): Myself and David, Rae Ann, Nika, Melanie, Sherry, and Tracy Jo.

(Patrick): Thank you so much to all of you. I got a lot of the pictures of how you decked out our booth. We are a program of attraction and it was a very attractive booth and you got absolutely nothing but positive feedback.

Unfortunately, with the Rawhide event coming up on Saturday, I was not able to get to it. So I owe you an amends, George, because you did give me the information and plenty of time to get that taken care of.

(Secretary summary follows) George and Patrick will work together to get registration and volunteers for the Visalia Pride Event on October 14th from 11 AM to 4 PM at the Visalia Rawhide Stadium. George will take the tote tonight, with the P.I. stuff in it. Carol Ann can fill out paperwork if registration forms need to be filled out. Ali commented that it was surprising

how many professionals thought you had to have insurance to go to A.A. or pay to go: she got many questions asking how much it costs to go. Carol Ann added that yes, she gets a lot of telephone calls asking how much it costs to sign up for our classes.

Bridging The Gap (BTG): provided by Sara S.

We had a meeting at the Central Office last Saturday with three of us: me, David, and another member, Mike S. We accomplished a lot. I talked with Brad E. from up north, and he gave us a template to fix our blue cards with the right address. Mike S. is updating the envelope template. Bridging The Gap helps connect people just released with the local A.A. community. I've been getting people interested, and though not everyone shows up, I now have a couple of committed members wanting to join the committee. Our goal is to use blue cards to meet people at meetings, introduce them to A.A., and explain how it works. The next meeting is on November 4th via Zoom, and already on the website. This way, people can join without driving to Exeter at 11 on a Saturday morning. Our next task is to finalize envelopes and templates and share information with recovery homes, prisons, and Bob Wiley.

Sara.

(Cheryl): Any questions for Sara? (Cody): What is the blue card? (Sara): A blue card is a tool we use to help people coming out of homes, prisons, and jails who might not know what to do next. They fill out their information on the blue card, send it to us, and then one of our committee members contacts them. We arrange to meet them at a meeting, introduce them to A.A., and explain that it's a free (volunteer) Twelve Step support program to help them get sober if they're willing.

(Cheryl) (*paraphrased by secretary*): I wanted Sara to give her report after Patrick because I'd like to clarify the roles of P.I./C.P.C. and Bridging The Gap in our area. Initially, Bridging The Gap was managed by Central Office, with Bob Hinton as the chairperson for Tulare County. When the Area got a consistent chairperson, they felt either General Service or Central Office should handle it. Central Office offered to continue, and a board member took on the role. Regarding P.I./C.P.C., a joint meeting with District 47 led to an arrangement where each entity managed one aspect. Later, due to challenges in District 47, Central Office took on both. If District 47 wishes to split responsibilities again, we are open to that. Central Office wanted board members to be active, not just attend monthly meetings without a role. Our board members are active in these roles to ensure engagement and contribution.

This month, we have had a couple of facilities cancel and/or reschedule H&I meetings due to Covid outbreaks. We seem to have moved past this and are back on track. We were able to hold 8 facility meetings, utilize 24 volunteers and distribute over 60 AA books to our inside members in September. The Tulare County Jail is now allowing us to add volunteers and we hope to have several more cleared and ready to go by the end of November. These volunteers will include 2 Spanish Speaking volunteers allowing us to reach more inside members. We are in need of more volunteers in order to expand to more facilities and encourage all interested to contact Joyce or attend our next meeting.

At this time, NorCal's financial position is **poor**. Year to Date our literature expense has increased 63.1% over last year while our contributions increased only 11.3%. This has now left us utilizing prudent reserve funds. Please encourage all groups to pass the Pink Can to ensure that literature is available for our inside members. If your group does not have a Pink Can, they are available at Central Office. Please ensure that groups are passing the pink can separately from the 7th tradition and it is noted that money from the Pink Can is distributed separately from the 7th tradition funds. The Pink Can is not meant to detract from the group's 7th tradition

responsibilities. When funds from the Pink Can are sent to NorCal, please indicate that the contribution is coming from Area 93.

October 22, 2023 is the next NorCal Committee Meeting. 


