

# How One AA Wife Lives the 12 Steps

Lois W., AA's "first lady" as the non-alcoholic wife of Bill, the co-founder of Alcoholics Anonymous, tells the story of her own adventure in growth applying AA principles to her own life.

"We have often heard it said that the Twelve Steps of AA are a way of life for anyone, if you substitute for the word "alcohol" any particular problem of life. For a close relative of an AA, a wife or husband, even the word alcohol does not need to be changed in the First Step; simply leave out "alcoholic" in the last, thus: "carry the message to others, etc."

I was just as powerless over my husband's alcoholism as he. I tried in every way I knew to control his drinking. My own life was indeed unmanageable. I was forced into doing and being that which I did not want to do or be. And I tried to manage Bill's life as well as my own. I wanted to get inside his brain and turn the screws in what I thought was the right direction. But I finally saw how mistaken I was. I, too, was powerless over alcohol.

# Central Service Meeting Meetings

### CENTRAL SERVICE MEETING MINUTES

Central Office and Central Service Representatives Meeting Report

Date: December 12, 2023

Meeting called to order: Cheryl H. Time: 7:00 PM

Board members present: Cheryl H., Bill E., Sara S., Patrick A., David G., Carol Ann G. Absent: none

Serenity Prayer: Lead by Cheryl H., said by all who wish.

12 Traditions (long form): Glenda.

Minutes of last meeting: Reviewed by all. One correction: CSR report for Tuesday Women's Amity Group is missing the word "meet" in the first sentence. Cody moved to approve, motion seconded by Bret. Vote: all in favor, none against.

Report of November Board meeting: Meeting called to order November 14<sup>th</sup> at 8:45 PM by Cheryl Hinton. Four of five board members were present; Patrick was absent with notice. During the board meeting, Cheryl, the President, reported that she had nothing specific to share but expressed her pride in serving as the president for the past four years. She highlighted the accomplishment of her set goals and emphasized the importance of each board member having specific objectives for office improvement. Bill, the Vice President, echoed a similar sentiment, trusting in the leadership and noting the positive financial position. He mentioned his two years as secretary and expressed a bit of sadness about leaving due to a personal situation but left open the possibility of returning in two years. David, the Secretary, apologized for being late with the minutes and expressed optimism about improving in the coming month. Sara, the Member At Large, shared her learning experience and outlined her goal of establishing a foundation for Bridging The Gap. She expressed joy in being part of the team and sadness about leaving. Carol Ann, the Office Manager, reassured the board about financial stability and expressed excitement about the future, despite some nervousness about the upcoming transition with the new board. During the discussion of old business, the board addressed current price changes, particularly the Big Book, which presently costs \$11.28 while the catalog price is \$12. Due to inflation, the decision was made to delay ordering until January and then adjust prices accordingly. The topic of changing pamphlet prices was also revisited, with all pamphlets experiencing a 30% increase, some even reaching 50%, due to challenges faced during the COVID pandemic. Ultimately, the board agreed to raise the price of the older alcoholic pamphlet to \$1 and change other pamphlet prices to 25 cents. The importance of maintaining the website's content within the scope of AA traditions and concepts was emphasized, particularly in regards to events without a direct affiliation. Nominations and elections for new board members were on the agenda, with a reminder for the new board to be in place for the January meeting. The meeting adjourned at 9:17 PM.

On November 17<sup>th</sup> I had a dentist appointment, Claudia covered the office for me. Claudia will be covering the office on December 19<sup>th</sup> for my doctor's appointment. Thank you Claudia! Central Office will be closed on Monday December 25<sup>th</sup> and Monday January 1<sup>st</sup> – New Year's Day in honor of the holidays. The Central Office will be open the last Saturday of the month which is December 30<sup>th</sup> 2023!

I had to notify Deluxe (the company that we bought our sales books from) to notify them that we had a duplicate invoice number in one of our sales booklets, in the sales registry we have 2 invoice number 9920 listed. A member suggested we use Porterville Sheltered Workshop; I got a quote; we switched printing companies for a savings of over \$200!

As per our rental contract with our landlord, our rent goes up \$35 effective Jan 1<sup>st</sup> 2024 bringing it up to \$685.00 per month effective until the end of 2027.

Central Office had an income of \$2,771.86 and expenses of \$4,987.56 for a loss of \$2,215.70

Our Grateful Givers Club brought in \$160.00 and our Birthday Club brought in \$24.00 in much appreciated contributions.

We had \$630.29 in 18 gross sales in transactions for credit and debit cards, \$20 in 1 transaction in PayPal, and 0 VENMO transactions this accounting period.

Traffic and calls have been average.

Office operations are going well and we are still fulfilling our primary purpose of carrying the AA message of recovery.

We have lots a great holiday stuff here at the Central Office to help you share the message of recovery, come and see what's new!

I would like to thank all of the groups and individuals who contributed to Central Office to make 2023 an awesome year!

December, 2023 H&I Report

In November, we conducted 10 H & I facility meetings. Unfortunately, one facility had to cancel both of their meetings due to Thanksgiving. However, we successfully held ten meetings and had two additional ones at the Tulare County Jail. Our efforts involved 33 volunteers, and we distributed 89 AA books.

In December, we are excited to announce the initiation of our monthly meetings at the Visalia Recovery Center. This will bring our total facility meetings to 13 per month, marking a positive growth for the year.

On December 9<sup>th</sup>, we hosted a voluntary appreciation luncheon to express gratitude to our dedicated volunteers. We value their commitment in spreading the message of AA and contributing to our continuous growth. As one speaker noted during the luncheon, the significance lies not only in what we do but in who we do it with. Over the past year, we've been fortunate to have around 35 steadfast volunteers consistently supporting and conducting meetings.

In terms of finances, NorCal has achieved a neutral position. This month, we experienced higher-than-average income and lower literature expenses, resulting in a reserve slightly above the recommended six months of operating expenses. However, we are mindful of a 42% increase in literature expenses compared to last year, with only a 16.8% increase in income. While it's an improvement from last month, we urge everyone to continue passing the pink cans to ensure a steady revenue stream, which would help bridge the gap comfortably.

For those interested in contributing, Carol Ann has pink cans, and you can contact her directly for more information. We also need more volunteers to support our initiatives. Several requests are pending, but we're hesitant to proceed until we have additional support. Our next volunteer orientation is scheduled for January 13<sup>th</sup> at 9 AM, followed by a business meeting at 10. The location is Bridge Street Drunks at 526 North Bridge Street in Visalia.

(Cheryl): Are there any questions for Joyce? (Cody): For the pink cans after they passed through, how often does the money get turned in? (Joyce): Each group can decide for themselves how to handle things because they're autonomous. At Bridge Street, we send money every month, but some groups do it every three months. It depends on what your group decides. (Cody): Does the money come directly to you? (Joyce): No, it goes to a P.O. Box in San Francisco. Then we contact the literature chair and they send us the literature. That's how that works. Thank you.

Bridging The Gap (BTG): provided by Sara S.

We had our Bridging The Gap meeting, December 2<sup>nd</sup> via Zoom. There were three attendees: myself, David G. and Mike S. We've developed a plan, or as we like to call it, "the plan." The idea is to establish a foundation and create a committee, bringing people on board and providing training for when we receive a blue card. If you're wondering what "Bridging The Gap" (BTG) is, it's all about connecting members who are transitioning out of facilities or incarceration with their AA community. Our committee members meet them at meetings, introducing them to the principles of Alcoholics Anonymous.

To make this happen, we're working on building a committee and organizing a training session. We want everyone to understand the do's and don'ts of Bridging The Gap. Recently, we nominated David G to be our facility coordinator. His role involves presenting information about BTG to various facilities, making sure they understand what we're all about and ensuring the availability of our resources for individuals who are incarcerated or in facilities.

We're thrilled about the prospect of expanding our committee and spreading awareness about BTG. Our meetings are currently held on Zoom, providing a convenient way for people to join

in. Our next meeting is scheduled for Saturday, January 6<sup>th</sup>, at 11 AM via Zoom. You can find the Zoom link on our website. Thanks for allowing me to be of service.

While this has left us utilizing prudent reserve, the issue to watch is the increase in expenses versus the increase in income. We hope that all groups continue to pass the pink can. The Pink Can is not meant to detract from the group's 7<sup>th</sup> tradition responsibilities. Please ensure that the pink can is passed separately from the 7<sup>th</sup> tradition basket. The Alcoholic replies, "of course not, my brother's fine. I just quit drinking"






