I have sought to utilize my will only as much as it is needed to make

things right,
I will be ready to move on from Step Three
& begin my true work in recovery.

There is a certain peace I feel when I walk into a meeting, I am with my AA family and I can talk about whatever I need to. I won't be judged for what I've done in the past, and people can relate to me in a way no one has ever done before. All I had to do was say "My name is Sheryl and I don't want to drink any more.

January was a busy month! I was able to submit all the forms required for the Social Security Office, The Secretary of State and Attorney General's Office to keep our non-profit in compliance. We also filed our 990EZ forms with the IRS.

Central Office had an income of \$8,386.10 and expenses of \$8,101.34 for a gain of \$284.76 Our Grateful Givers Club brought in \$141.13 and our Birthday Club brought in \$72.00 in much appreciated contributions.

We had \$757.53 in gross sales in 17 transactions for credit and debit cards, \$20 in 1 transaction in PayPal, and \$1012.36 in 12 VENMO transactions this accounting period.

Traffic and calls have been average.

Our Bi-plate and Gold Plate chip supplier informed me they will be discontinuing these products in the future because of the high cost of precious metals.

Also, I ordered some aluminum chips and they changed the color on us, the 4-month chips I had are gold and the new 4-month chip they sent us are purple! #### H & I Report

In January, we were able to hold 12 H&I Facility Meetings (one was cancelled by the facility) and 2 H&I meetings in the Tulare County Jail. We utilized 31 volunteers and distributed 102 AA Books. This month, we had 9 volunteers attend training at the Tulare County Jail which included two Spanish speaking volunteers. We hope to have all cleared in the upcoming months and increase our H&I meetings at that facility.

NorCal's financial position moved to <u>sound</u> at the end of January 2024. We ended the month with a positive cash flow of \$9,432.17. This was due to a one-time bequest of \$9,000 and an individual member contributed \$5,000, (the yearly max per individual) for a total of \$14,000. While we are grateful for the contributions. In order to maintain distributing literature as we have been accustomed, we will need steady monthly contributions which match our monthly expenses. We encourage all groups to continue to pass the pink can at their meetings and have the treasurer send in the money on a consistent basis. The Inside Visiting Sponsorship Service which provides inmates with outside sponsors is gearing up to begin at the Women's facility in Chowchilla. Please encourage any women with 5 years of sobriety and sponsorship experience who are interested in this type of service, reach out to me to be connected with the new coordinator.

<u>CSO Liaison Report:</u> David G. Our January CSR Meeting was held January 10. The meeting was a hybrid meeting, with one member joining via Zoom. There were thirteen people present inperson.

Central Office finances: for November 21 through December 20, Central Office had income of \$4,115.64 and expenses of \$3,451.60 for a gain of \$664.04.

#### Old business:

1. New Year's Eve event: it was a success: Glenda & Debbie did a great job. It was smooth, flawless and fun.

#### New business:

- 1. Founders Day Picnic: we need a chairperson. George and Jason will be happy to assist.
- 2. Unity Event Committee: please ask your group what sounds fun and report back any suggestions. So far, park barbecue, painting night, softball, and bowling seem to be popular.
- 3. After-hours phone service: all after-hours phone calls are still going to Cheryl H., but it would be good to rotate this service position. Cheryl has been doing it since pre-Covid.

#### Questions and answers:

When will Founders Day Picnic be? June 8, 2024 at Arbor 9 in Mooney Grove park in Visalia.

When will these other Unity events be? We're still planning and want feed back from the groups what they want to do.

If someone wants to sign up to take after-hours phone calls, how do they do that? Call Carol Ann at Central Office to be put on the list. This next CSR meeting, we will hear about telephone call distribution software and prices.

**Registrar:** Josh F. My update is that this month I have no report.

**<u>H&I Report:</u>** Jason K. on behalf of Joyce R., Tulare County Hospital & Institution Committee Liaison

In January, we were able to hold 12 H&I Facility Meetings (one was cancelled by the facility) and 2 H&I meetings in the Tulare County Jail. We utilized 31 volunteers and distributed 102 AA Books. This month, we had 9 volunteers attend training at the Tulare County Jail which included two Spanish speaking volunteers. We hope to have all cleared in the upcoming months and increase our H&I meetings at that facility.

NorCal's financial position remained Neutral at the close of 2023 as we are slightly above your 6 months recommended cash reserve. In 2023, we purchased \$471,399.05 in literature which was 89% of our total expenses. The literature was distributed at the 25,200 meetings NorCal H&I supports. However, our income after processing fees was \$467,152.37 which left us ending the year with a negative \$60,669.07. While it is not sustainable to operate at a loss, if we work together to encourage groups to continue to pass the pink cans together, we can create a revenue source that meets our expenditures. If your group does not have a pink can, they are available at Central Office or by contacting me directly.

The Inside Visiting Sponsorship Service which provides inmates with outside sponsors is gearing up to begin at the Women's facility in Chowchilla. Please encourage any women with 5 years of sobriety and sponsorship experience who are interested in this type of service, reach out to me to be connected with the new coordinator.

We are in need of more H&I Volunteers in order to continue growing as we begin the new year. Please send any interested AA members to our next Orientation: March 9, 2024, 9:00 am followed by the Area H&I Business Meeting at 10:00 am. The meeting is held at Bridge Street Drunks Only, 526 N. Bridge St., Visalia, CA 93291.

What times are the orientation and business meetings? Orientation is at 9:00 AM, every month, and the Business meeting is at 10:00 AM every other month – next one is in March.

#### **DCM Report:** Mike C.

I went to the Winter Assembly in Merced, and took some notes. One of the suggestions by our Delegate was to compile a binder of service positions, with a one page form description of responsibilities, which can then be given to new position holders. Another was to hold a GSR Workshop; Emily L. will work with us, and she read the pamphlet *The GSR is the most important position in A.A.* Regarding agenda topics for the annual conference in New York, the material will be available in mid-February. We should pick four or five and to discuss with our groups, so the GSR can go to the Pre-Conference Assembly and present an informed opinion from our groups. Next was a presentation by Matthew L., our Delegate. Matthew said it was important to get a Service Sponsor. Also, consider asking your group to PRAASA, which is in San Francisco this year. Speaking of out-of-town events, I (Mike) might be going to the NCCAA event March 15, 16, 17 in San Jose, if anyone wants to carpool. Holly, our Alternate Chair, said that there are documents available on the website for officers who want to bid on holding an Assembly. Don, our Area Treasurer asked that when groups send in contributions, to please put your group number on the check. Also, our Archives facility rent is being raised, so Area 7 has created a committee to find a new location. They came back with three or four options of different facilities in Carmichael,

Stockton West, and Sacramento. They would like to find a facility which can do all three: hold the Area Committee Meetings (ACMs), audio/visual equipment storage, and be the Archives office. Under Area New Business, they want to start up an Accessibility Committee which will provide Uber rides to meetings and sign language interpretation.

#### **Old Business:**

Zoom account sharing with Central Office was approved by the board.

#### **New Business:**

Discussion about possible fundraising activities to help support GSRS whose home groups can't pay for the full cost for them to go to PRAASA in San Francisco, or the Pacific Region conference coming up in Las Vegas in July. NCCAA will be doing a spaghetti dinner, for example. The deacon at St. Paul's Episcopal said they would charge \$125 for a morning, and they do have a kitchen. Jason said that N.A. had a breakfast at the Alano Club, although they don't have a kitchen (only a sink) so members brought in a camp stove/grill.

Co-hosted agenda items workshop with Fresno County. We were approached by Bill, a DCM from Fresno: he had asked Matt (Delegate) if can come do an agenda items workshop. Then Bill asked us if we want to co-host. We would need to vote tonight. Jerri suggested that we say "How about next time we have one of these, that they come this direction and help us?" Motion made and passed that we co-host the agenda items workshop with Fresno County.

Co-hosted Post-Conference Assembly with Spanish District 55 in May. I met Simon, the DCM and he asked if, because a lot of their members don't speak English very well, if we'd be willing to help co-host with them with the registration and some of the sales. If we wanted to sell some breakfast items or lunch items and then we could split the profits on that. Motion made and passed that we agree to co-host and supply volunteers for the event.

Discuss attending PRAASA in San Francisco, March 1<sup>st</sup> through 3<sup>rd</sup>. Does anyone else want to go and carpool? Mike will likely go to the NCCAA conference in San Jose March 15<sup>th</sup> through 17<sup>th</sup>.

Discuss dates for hosting hybrid GSR workshop. Emily, alternate chair for CNIA 7, is willing to do a GSR School / GSR Workshop on Zoom. Consensus was yes, we should do this in March. Mike will ask Emily how long it will take; depending on the answer we will do it either during the GSR meeting or on a separate event.

Remaining three items on the agenda tabled to next month.

<u>Declaration Of Unity:</u> Read by all: "This we owe to A.A.'s future: To place our common welfare first, to keep our fellowship united. For on A.A. unity depend our lives, and the lives of those to come."




