## Step 1

"We admitted we were powerless over alcohol—that our lives had become unmanageable."

When I first began my sober journey, I had a fear that I would lose so much by giving up alcohol. So much so that when I entered the rooms of AA completely broken, that I called a friend crying exclaiming, "I don't want to be an alcoholic!".

It was hard to admit defeat, because after all, I had a home, a college degree, a career, and a vehicle. I had a complete different version of what an alcoholic "looked like" in my head. As I navigated my way through step one, opened the big book, and began attending meetings regularly, I began to realize that alcoholism is not a disease that discriminates. It is a disease that robs your soul.

My sponsor asked me to read step one and think about what the unmanageability looked like in my life. Every time alcohol touched my lips, I had no control over what would happen next, and the truth is, I didn't want to try to control myself. When I tried to control it, or "drink like a lady", it felt exhausting. All of my relationships were centered around alcohol, and I put myself in many unhealthy situations while under the influence. I cried often and could not imagine a way out of this cycle I was n of damaging myself, letting others damage me, and carrying on with the motions of life. Doing what I thought was best. When I was not drinking, I was thinking about when I would have my next drink. Even when I was thinking about not having a drink, I would think about stupid stuff I was engaging in while I was drinking. The party was over, and escaping from reality was causing me a great deal of pain.

So I decided to try something new and face defeat to my new sponsor. I admitted I was powerless over alcohol and my life had become unmanageable. I admitted that I had no tools to combat the mental obsession and I truly had no idea what the heck to do next. Thankfully, I met a lot of beautiful people along the way in the rooms of AA who have provided me with love, guidance, and grace.

Admitting that I am alcoholic feels like a relief now, as it allows me to understand that I can not control my drinking, and I shouldn't try. Giving up alcohol is giving up ONE thing, and I have been rewarded with many gifts as a result. The gift of being present. The gift of liking the woman I see in the mirror. The gift of being a better daughter, sister, friend, and employee. The gift of a closer connection o God. The gift of early mornings without a hangover. The gift of not thinking about alcohol every day.

## Tradition 1 "Our common welfare should come first; personal recovery depends upon AA unity."

There's nothing powerless people like more than a little bit of power. When I was new to Alcoholics Anorymous, my temperament was childish. I wanted what I wanted and believed everything I thought. Yes I had been beaten into a state of reasonableness, but only concerning alcohol. I had a lot of ideas on how things should be and was saturated in resentment and disappointment. These traits are poison to alcoholics. A person who thinks they know everything will never learn anything.

I started attending the business meetings at our fellowship and saw something unfamiliar to me. People sharing opposing opinions, working toward a consensus despite occasional hurt feelings and finally settling on what was best for the group.

What a gift it was for me to share my opinions! It's something I've never shied away from. Even when no one has asked me for them. The thing about opinions is that they are usually based on limited information, otherwise they would be better termed convictions. Having destroyed my life with poor choices based on what I thought, it wasn't much a leap to consider that I may not know what's best for the rest of you either. My sponsor taught me that while wanting to be right could likely cause problems, the need to be right would lead me back to the bottle.

How often I've heard in meetings that a persons' Higher Power works through other people. One example is when my ego tells me that what someone is sharing is useless, and then someone else will thank them for the valuable information. My Higher Power used both of those people not only to give them a vital connection, but also give me a spoonful of humility and consideration of what might benefit someone else. Miracles I never expected.

I like the analogy in the Big Book of being survivors from a shipwreck. Anytime I'm in a meeting that is in a circle, I try to imagine being in a life raft. In that situation my life would depend on non-chaotic cooperation.

When I am disconnected from my Higher Power, it's more obvious to other than myself sometimes to see when it is my ego doing the sharing. "We can't transmit something we haven't got." I appreciate the members who are connected to their Higher Power and can demonstrate correction in supportive manners. Imagine if all we had to rely on was ego to settle our differences. We would tear our life raft to shreds.






