Alcoholics Anonymous-Step Eight

Made a list of all persons I had harmed and became willing to make amends to them all. I have been fortunate to find myself willing to do the unfamiliar and uncomfortable at times thus far as I have begun and continue to embrace the AA way, this includes unity, service and recovery. As I heard many times in my infancy of membership in AA, it was engrained in me the importance of meeting attendance, sponsorship and beginning my steps if I wanted to make progress and this was a little daunting. To be honest my only intention was to control my alcohol consumption or maybe eliminate, for how long I did not know, but I did know that it was causing harm to me and I finally came to admit that I was not the only one that it was harming. That is what comes into question for me while I am writing this piece surrounding step eight of the twelve steps of AA. Too many times I said that I was "SORRY" and I really was. However, that did not generally lead to changed behavior on my part for very long. In order to embark upon the work that step eight requires I had to learn the difference of "sorry" and "amends" in order to actually make progress in this journey which includes not just healing from within, but doing my

part by trying to heal some of the wounds that my actions had caused others. In my case, I knew that this task would not be a simple process and definitely not done to perfection, so I was aiming for "progress not perfection." And with that I just started by making a list of those that I had wronged which was mainly my immediate family as they are the ones that mainly dealt with my indiscretions in the past. Numerous sorries had been said before and would likely be said again for the exact same reasons if I had continued the misuse of alcohol and the behaviors that accompany it, so my hope was that my amends would help guide us to a better place. I had an unexperienced viewpoint of step eight so it was another AA member, my sponsor, that was there to point out that my step eight was good progress for me as I continue this journey of recovery.

However, as this step is a precursor for step nine I shared with him my plan to tackle step nine for those I mention in step eight on Easter since my children, spouse and mother and I would all be together and I generally seek out an "efficient way" of completing tasks! Grateful I am, that he pointed out to me my interactions with my wife, mother, daughter and son are all different. And so are their perceptions and experiences with me. This meant that in addressing step eight through step nine I may want to rethink and alter my approach and it made perfect sense and seemed so obvious after he pointed it out. My ignorance was erased by my willingness to listen and learn from another member of AA, in this case my sponsor. I passed on my "Easter Plan" and met with each of those fore-mentioned family members individually at a later time. He has been selfless with me and truly a mentor throughout my journey so far. I did not think that I would like this sponsorship thing, but it has been an unanticipated benefit that I recommend it to anyone that has not yet embraced being a sponsee. Their experience is valuable! My write-up here is not a clean piece strictly about step eight only because for me it was about eight and what would follow in step nine as a result of working with my sponsor. I have learned that sponsorship is about mentorship for someone that is willing to learn from experienced AA members so that progress can occur. Step eight has been written into the books for me for the first time, yet I know that there will be a rewrite down the road in order to my continue progress. So until my next step eight, I will work on not adding names to the list and continue to do my best incorporating the steps into my life.

Short Form: "Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers."

Everyone who comes in to this office is of service to a meeting; buying books, chips or making a contribution, a member getting something special for someone celebrating a sobriety milestone. Wonderful people giving back to the program that is saving our lives! YOU are the special workers in AA! Think about it, we have someone show up early and unlock the doors to your meeting and that person may also be the coffee maker for your meeting. (Some coffee pots take an hour to percolate in those huge pots!) Most groups have a Treasurer who pays the rent and distributes contributions to the other AA entities. I have seen large meeting with many more service positions, so, AA has a vast number of special workers all over the world, people are doing stuff behind the scenes before we ever get to our meeting! Without these humble servants, there would be no AA! Thank God for these members, with out them I would not have the life I have today!

Through your contributions, our website reached over 2,900 people this month alone! Thank God for our humble servant David G for keeping it up and running, a VERY SPECIAL WORKER INDEED! So grateful we don't have to pay for his services! We have members who travel great distances to District, Region and Assembly meetings to discuss AA business solely for the benefit of AA as a whole! You are our special workers!

As the Office Manager aka special worker, I have been accused of being a person who badgers meetings for money! My job is all about the money! I am in the financial trenches of this office daily, and I know what expenses we have coming up and what we have recently paid out. I am just trying to let groups and individuals know that in order to continue to share the message of recovery **we need contributions regularly**, **not just once or twice a year**.

I am the only paid AA member at the Tulare Central Office and this office operates solely through contributions! Those contributions make it so we can afford to rent an office that has all the things you need for your meetings! The contributions pay for me to be here to run this office as paid staff 20 hours a week for \$23.22 per hour. Most of the payroll taxes come out of my paycheck but you are supporting the office's portion of payroll taxes, literature purchases, chips, meeting schedules, and our website expenses, insurance and all the office expenses. (In case you feel I am over paid, the office manager at the Chicago Central Office works 40 hours a week and makes \$90,000 a year, or \$43.27 an hour!) We are professionals who do an important job!

AA is an organization that many legal obligations, as we are held accountable to many governing agencies. This Central office is in compliance with them all and we are good until 2026 when we start that process all over again.

Each group is totally self-supporting and hopefully has money left over to support the AA triangle of service; us here at Central Office, your district, and AA World Services so that anyone anywhere reaches out for help anywhere in the world, they can find us! Like any business we have monthly expenses and the only way we can meet those expenses is if we get groups and member to contribute regularly!

We have 3 member who send money each month THANK YOU! We would love it if more of our members and groups could contribute monthly.

The new board made an agreement with me that if we are below our current prudent reserve of \$19,000, we will close the office effective immediately on Mondays. This takes away 20% of my already part time salary and that hurts.

With all the groups and members we have in our area, there should be no reason why we can't keep this office open for 20 hours a week. So, I am reaching out to you, one of the members of our life saving organization to please talk to your conscience and your groups to see about increasing the amount you put in the basket, and also think about sending in **monthly** contributions to us! You can send them in through our website via PayPal, VENMO or as part of your monthly bill paying processes!

I generate the group contributions report every month with monthly and yearly contributions for each group. I am asking you to assess what your group has been collecting and how much is actually going to AA entities starting with us, your local AA headquarters, and AA World services, as well as your District and Area. We all have bills to pay!

So again, a huge thanks for your contributions, Tulare County Central Office Inc. and AA General Service Office Inc in New York are able to employ special workers! We are running the business side of AA through your contributions, so thank you and keep them coming!

It is an honor and a privilege to be the Office Manager here at Tulare County Central Office Inc, your local AA headquarters!
