Local AA Members Share Their Experience of the 12 Steps & 12 Traditions

Step 9

Made direct amends to such people wherever possible, except when to do so would injure them or others.

When I first started working the steps with my sponsor I was only 6 months sober. I didn't know very much about this new journey in Alcoholics Anonymous. The one thing I did know was that people who'd been sober for some time and were comfortable inside there own skin had <u>done</u> the steps. In their pitches in meetings they would mention the freedom they got after working the 9th step. They would often give the description in the same breath that they were cleaning away the wreckage of the past. I saw that as an attraction and I wanted what they had. At last there was <u>hopefully</u> a solution...that things could change. I say hopefully because this 'leap of faith' of taking ownership of my wrongs was totally new to me. But seeing the piece of mind and serenity in my sponsor and others who'd worked this step gave me the hope that I needed.

Of course I had no idea of the wreckage I'd caused until I'd done steps 4 and 5. But the positive change that I'd seen from doing <u>all</u> the previous steps gave me the incentive to do the next indicated thing. At first I tried to make an amends without first discussing it with my sponsor. Afterwards, it just didn't feel right because the true intent wasn't conveyed. So my sponsor and I decided to write out the amends. I then would go to that person and read the amends as written. (Which made for screwing up the amends pretty tough.) So I began to have some success with the 9th

step amends process. I began to get some freedom from the guilt and remorse from my behavior, which actually gave me the incentive to make another amends. Whatever the wrong was, my sponsor would always have me say "I was wrong for doing that, and I'll try not to do that again". Whatever the amends was about, I would always admit where I was wrong. If I was also sorry for what I did, I would say that also. But if I wasn't sorry for what I did, I wouldn't force myself to apologize. I instead would admit the fact where I was wrong and leave it at that. I have come to realize now that me saying that phrase wasn't for them, it was for me! It started a change in the way I reacted to others. I started to respond to those stressful situations we sometimes encounter with love and tolerance; rather than behaving badly. The resulting change in this recovered alcoholic has been a spiritual awakening that continues to this day. All the old, self-centered behavior that used the plague my previous years has been replaced by someone I'd never thought I could be.

Another practice that I've learned to do with my amends is to say the amends, excuse myself and <u>leave</u>. Not as a snub, but to cement the idea in both of our minds the importance of what I'd said and that I MEANT IT. And then the statement that "I was wrong for doing that and I'll try not and do that again" really sinks in and reminds me not to repeat that behavior again.

I leave that person after making an amends for another reason also; if I instead linger with that person and have a casual conversation (like I did with my first amends), the sole purpose of making the amends can be diluted. I can just remember that feeling I had that day I "hung around" after making an amends. I so much wanted a 'do over' because it had not gone the way I wanted.

So I've learned over the years is to complete my amends in certain manner. But to be honest with you, no matter if I'd fumbled an amends or said it with perfect pitch and clarity, my message was always heard just as it was supposed to be heard. God made sure of that. Afterwards, I experienced another spiritual "God Shot" that we can get in Alcoholics Anonymous. Through working the 9th step, my higher power has allowed me to change my behavior for the better. It's not 100% better yet, but it's closer. And that's why we have the 10th step...to continue to check our bad behavior if we falter on our journey...but that's gonna be covered next month. Stay tuned...

Tradition 9

The A.A. Traditions were written for groups of A.A. members, addressing things their groups will likely face. Tradition Nine is about organizing.

We do find value in stepping up and being of help. On the personal level, it may be a sponsor helping a sponsee work through the steps. On a committee level, we can still be of help, but the fact that multiple people are also helping adds complexity. Who is in charge? Should anyone *be* in charge? What is the goal of the committee?

I enjoy being a part of a Ninth Tradition Service Committee in Tulare County: the Hospitals and Institutions Committee. Early A.A. members saw that there was a need: bringing experience, strength, and hope to people who cannot get out to our traditional meetings. Thankfully, the goal of H&I is clear: bringing meetings to people otherwise confined. We've been doing that for a long time, and it is going well. If you want to join us (and have some sobriety under your belt), we welcome you.

There are other Ninth Tradition Service Committees in Tulare County, although I don't know that they identify themselves as such. I'm thinking of the Founder's Day Picnic Committee, the New Year's Eve Party

Committee, the Public Information Committee, the Young People's Committee, the Spring Into Sobriety and Soberfest Committees.

I'm out of touch with the Young People's Committee, so I don't know what they would say their goal is, and how well they are meeting that goal.

I do know about the New Year's Eve Party Committee, the Spring Into Sobriety Committee, the Founder's Day Picnic Committee, and the Soberfest Committee. These committees have a simple and singular goal: organizing an event. The sub-goals are that the event is fun for all attendees, the event brings a message of recovery through A.A., and the event brings our local community together. My experience is that these sub-goals are always met. Where we get into trouble, is if one person gets tasked with too much. "Many hands make light work" is true, but sometimes we don't have enough hands. We're a fellowship, not a formal organization. We don't have a Project Manager who has the job of checking up on people to see if their part of "The Project" is on-track. Besides, we Alcoholics are sensitive people. Having a Project Manager riding our butts, checking on the status all the time, would quickly lead to volunteers vacating their positions in a snit.

So we have this weird push-pull going on. At the committee level, we *know* that getting more volunteers makes everything go better and easier. But we also cannot in any way *compel* people to help. We know that being a part of an event committee makes us feel good when the event goes well. But just like a sponsor cannot work the steps for their sponsee, our event committees can only tell our potential volunteers that if they try it, they will like it. Please consider joining us in a small way, and help out that member who has taken on too much. His or her load will be lightened, and you will have been of genuine help in meeting a committee goal that benefits our community.
